### Summary:

In July 2025, the City began the process of updating its Strategic Plan. In preparation for the November 17, 2025 Work Session and to build an environmental scan which includes a multitude of perspectives on the City's current situation, the team reviewed available documentation and data, and received input from members of City Council and City management.

The goals of the work session are to (1) share findings and review the situation assessment prepared by Baker Tilly, (2) gather Council input on the City's current mission, vision, and value statements; and (3) gather Council input on strategic goals and potential objectives to guide the City for the next five years. The Work Session will be facilitated by members of the Baker Tilly team.

There will be more touch points in 2026, as the Strategic Plan begins to take shape, including opportunities for community input through a survey in February with Council consideration of a final draft anticipated for March 2026.
