Our Salem Flyers

Flyers and posters were hung around Salem and distributed by various partners at multiple stages during the Our Salem project. Flyers were posted and left at Center 50+, Salem Public Libraries, various grocery stores, the Mano-a-Mano offices, Salem City Hall, and at events citywide (see events section of this outreach summary). Flyers were also printed for distribution by Pineros y Campesinos Unidos del Noroeste (PCUN).

Large maps were printed and hung at Salem City Hall to show the proposed Comprehensive Plan Map during Phase 2 of the project (fall/winter 2020), the proposed zoning map during Phase 3 (fall 2021), and the proposed Comprehensive Plan Map and zoning map during the adoption process (Winter 2022). These maps provided an opportunity for those without internet access to view proposed changes.
