
PROJECT LOCATION MAP

RESOLUTION NO. 2023-XX

A RESOLUTION DECLARING THE PUBLIC NEED TO ACQUIRE RIGHT-OF-WAY AND EASEMENTS FOR THE PURPOSE OF CONSTRUCTING PEDESTRIAN IMPROVEMENTS ON MACLEAY ROAD SE AND CAPLINGER RD. SE

Whereas, for the purposes of the Macleay Road SE at Caplinger Road SE Pedestrian Improvements Project ("Project"), it is necessary for the City of Salem ("City") to acquire right-of-way (ROW) and temporary construction easements over certain real property depicted on "Exhibit 1," which is attached hereto and incorporated herein by reference ("the Properties"); and

Whereas, the Project is an approved capital improvement project currently being designed for construction; and

Whereas, for the public purposes of improving the streets, including the construction of the Project, the City Council has deemed necessary the acquisition of certain property rights, which the City is authorized by law to acquire.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SALEM, OREGON, RESOLVES AS FOLLOWS:


Section 1. The City does hereby find the Project to be in the public interest and declares a public need for the easements in order to construct the public improvements for the Project.
