| 5  | Section 1. SRC chapter 9 is hereby amended as set forth in Exhibit A, attached hereto and by      |
| 3  | this reference incorporated herein.   |
| 6  | Section 2. Findings. The Salem-Willamette Valley Airport is geographically located in the         |
| 7  | center of Oregon's Willamette Valley and serves as a transportation hub for commercial,           |
| 0  | military, emergency response, and general aviation services for not only the Salem metropolitan   |
| 8  | area but the greater Willamette Valley. The establishment of commercial passenger air service at  |
| 9  | Salem Municipal Airport in October 2023 reflects the demands of a larger, more regional           |
| 10 | passenger market. The imposition of additional landing fees and aircraft parking fees will ensure |
|    | continued viability of the airport. The amendment to the Salem Revised Code is in the best        |
| 11 | interest of the public.   |
| 12 | Section 3. Codification. In preparing this ordinance for publication and distribution, the        |
| 12 | City Recorder shall not alter the sense, meaning, effect or substance of this ordinance, but      |
| 13 | within such limitations, may:   |
| 14 | (a) Renumber sections and parts of sections of the ordinance;                                     |
| 15 | (b) Rearrange sections;   |
| 1. | (c) Change reference numbers to agree with renumbered chapters, sections or other                 |
| 16 | parts;  |
| 17 | (d) Delete references to repealed sections;   |
| 18 | (e) Substitute the proper subsection, section or chapter, or other division numbers;              |
|    | (f) Change capitalization and spelling for the purpose of uniformity;                             |
| 19 | (g) Add headings for purposes of grouping like sections together for ease of                      |
| 20 | reference; and  |
| 21 | (h) Correct manifest clerical, grammatical or typographical errors.                               |
| 21 | Section 4. Severability. Each section of this ordinance, and any part thereof, is                 |
| 22 | severable, and if any part of this ordinance is held invalid by a court of competent              |
|    | jurisdiction, the remainder of this ordinance shall remain in full force and effect.              |
