END NOTES TO CHANGE ORDERS:

1. Change Order No. 2 adds \$76,592: Provides for the fire sprinkler design and preconstruction and the envelope consultant to provide assistance and peer review on all exterior and waterproofing designs.

2. Change Order No. 4 adds \$67,108.72: Provides for the discovery of impacted soils that contain low levels of diesel and gasoline; unknown heating oil tank; and time extension.

3. Change Order No. 1 adds \$25,648.95: Provides for the specially equipped drill rig configured for (and a crew trained for) night-time work and adjustment for soils and groundwater testing services.

4. Change Order No. 1 adds \$32,190: Provides for the painting of the SE portion of the structure due to conflicts with tenants. This additional cost is to re-mobilize, re-prep the surface, re-rent equipment, and complete the project.

5. Change Order No. 2 adds \$3,739,741.56: Provides for the establishment of the Guaranteed Maximum Price through reconcillation of the amounts associated with Phase 1 and 2 of the project and authority to the design/build contractor to proceed with Phase 3 and 4 tasks and deliverables through construction, project closeout, and warranty phase. Phase 1 will generally consist of program validation and schematic design. Phase 2 will consist of providing detailed design and production of construction documents. Phase 3 will primarily consist of construction of the improvements. Phase 4 is a 1-year warranty period following construction.

6. Change Order No. 2 adds **\$87,400**: Provides for additional EMS medical supplies and small equipment increase due to EMS transport through Salem Fire Dept.

7. Change Order No. 1 adds \$26,000: Underestimated usage for this fiscal year.
