END NOTES TO CHANGE ORDERS:

- 1. Change Orders No. 1 and 2 adds \$38,695:** Provides for additional data scope for the access control system as well as the power to the controller and ADA doors. In addition, provides for the bathrooms to be reconfigured to meet ADA requirements and new counters and flooring.
- 2. Change Orders No. 1 and 2 adds \$192,595.34:** Provides for the construction of a new approach slab on the north end of the Liberty Street Bridge. The work includes removing the existing metal forms and foam on the north end of the bridge that were installed by an ODOT project in 2006, installing new metal sheeting to allow for placement of new embankment material, and the pouring of a new bridge approach slab. The City also directed Contractor to perform the following items of work: remove existing crosswalk striping on Mill Street SE at the intersection of Liberty Street SE, including removing the existing stop bar and approximately 5 Lin. Ft. of existing yellow centerline.
- 3. Change Order No. 1 adds \$65,000:** Provides for upfitting more new vehicles than anticipated.
- 4. Change Order No. 2 adds \$54,854:** Provides for the annual cost for year 3 of the contract.
- 5. Change Order No. 1 adds \$28,032:** Provides for the department to keep the rental longer than anticipated.
- 6. Change Order No. 1 adds \$50,000:** Underestimated annual usage for this fiscal year.
