# Dear Salem City Council:

The Creekside Homeowners Association Inc. (the "HOA") met on Monday September 23, 2024, to discuss the HOA's position on the appeal associated with Case No. PUD-SUB-PAR-UGA-ADJ24-01. This was a follow-up to previous discussions the HOA and various members have had with Don Lulay on behalf of the applicant (collectively the "Applicant") regarding the development proposal, the sidewalks that have been proposed, and the concerns associated with adding additional sidewalks along the northside of Creekside Drive between the access points for the proposed Villa Loop.

While the HOA is concerned with sidewalk connectivity and making sure that there are safe, accessible sidewalks throughout Creekside, the HOA does not believe that the addition of sidewalks between the access points along the northside of Creekside Drive will provide a benefit to the HOA, but they will add costs as the HOA will be the party responsible for the long-term maintenance of these sidewalks. The HOA is comfortable with the Applicant's proposal to add some sidewalk along the northside of Creekside Drive, providing connectivity to the proposed Villa Loop from the current termination of the sidewalk along the northside of Creekside Drive, the addition of sidewalk along the frontage of the proposed lots that will have access onto Creekside Drive, and the completion of the sidewalk along the south side of Creekside Drive from the current termination of the sidewalk to Clubhouse Drive SE.

The HOA thinks that the Applicant's proposed improvements will provide our community with pedestrian connections that will both improve pedestrian safety and provide a better pedestrian experience while avoiding the addition of sidewalks that will add cost for both the Applicant and the HOA.

The Creekside HOA supports the Applicant's application, including its request to remove Condition of Approval 14.

sidewalk on Creekside Drive but we can accomplish that by having the sidewalk on the south side completed. ### Hello Tom:

I hope you are doing well and enjoying the cooler weather. In reviewing the Decision of the Planning Commission with Multi/Tech after the HOA meeting we were informed that the Planning Commission did add an additional condition of approval requiring sidewalks along the northern side of Creekside Drive between the two access points for Villa Loop. As we had mentioned to you prior to the hearing, adding a sidewalk here significantly increases the cost of the project which will push up the cost of the ultimate units to a degree that Don is not comfortable with, so we will be appealing the decision.

As I recall, there was a homeowner that testified and requested sidewalks, but I believe we spoke with her after the hearing and explained that the cost would be significant and pointed out that the sidewalk along this side of Creekside would end after the property and not start again until the intersection with Lone Oak. I think she was comfortable with that, and I believe that the HOA Board understood that as well.

Going into the appeal, I want to make sure that this is in fact the HOA's opinion and, if so, see if you might be willing to support our appeal to get that condition removed with a letter. Don's position is that if this sidewalk was actually providing pedestrian connectivity in a meaningful way, he would build it, but because the plan is to already provide sidewalks and connectivity to the southside, and along the frontage of the northside of Creekside Dr to complete the sidewalks up to Villa Loop and along the frontage of the two houses with access onto Creekside Drive, that this doesn't seem to really add value, but will ultimately add cost for maintenance for the HOA and to the purchase price of the units themselves.

Please let me know what your thoughts are.
