5725 Skyline Road S and Land Adjacent

A portion of that real property described in Instrument No. 2024-06820, Marion County Deed Records, and that portion of Skyline Road S right-of-way, situate in the Southeast One-Quarter of Section 17, Township 8 South, Range 3 West, Willamette Meridian, Marion County, State of Oregon, and being more particularly described as follows:

Beginning at the northwest corner of the land described in Instrument No. 2024-06820, Marion County Deed Records, said corner also lying on the Now Existing City Limits Line as established in City of Salem Ordinance No. 28-07;

Thence leaving said Existing City Limits Line and running along the north line of said Instrument No., South 89°42'20" East, 230.74 feet to a point lying the west right-of-way line of Skyline Road S, said point also lying on the Now Existing City Limits Line as established in City of Salem Ordinance No. 12-24;

Thence continuing along said west right-of-way and the Now Existing City Limits Line, South 33°13'20" West, 35.74 feet to the southwest corner of said Ordinance;

Thence leaving said west right-of-way line and continuing along said Now Existing City Limits Line, South 89°42'20" East, 59.57 feet to a point of intersection with the east right-of-way line of Skyline Road S;

Thence leaving said Now Existing City Limits Line and continuing along said east right-of-way line, South 33°13'20" West, 491.79 feet, more or less, to a point of intersection with the Now Existing City Limits Line as established in City of Salem Ordinance No. 28-07;

Thence leaving said east right-of-way line and continuing along said Now Existing City Limits Line, North 00°09'56" West, 442.80 feet, more or less, to the Point of Beginning.

The above-described property contains 1.43 acres of land, more or less, of which 21,883.62 square feet (0.50 acres), more or less, lie within the existing right-of-way of Skyline Road S.

The Basis of Bearing for this description is North 89°42'20" West along the north line of Bella Cresta, recorded in Volume H46, Page 45, Marion County Book of Town Plats.

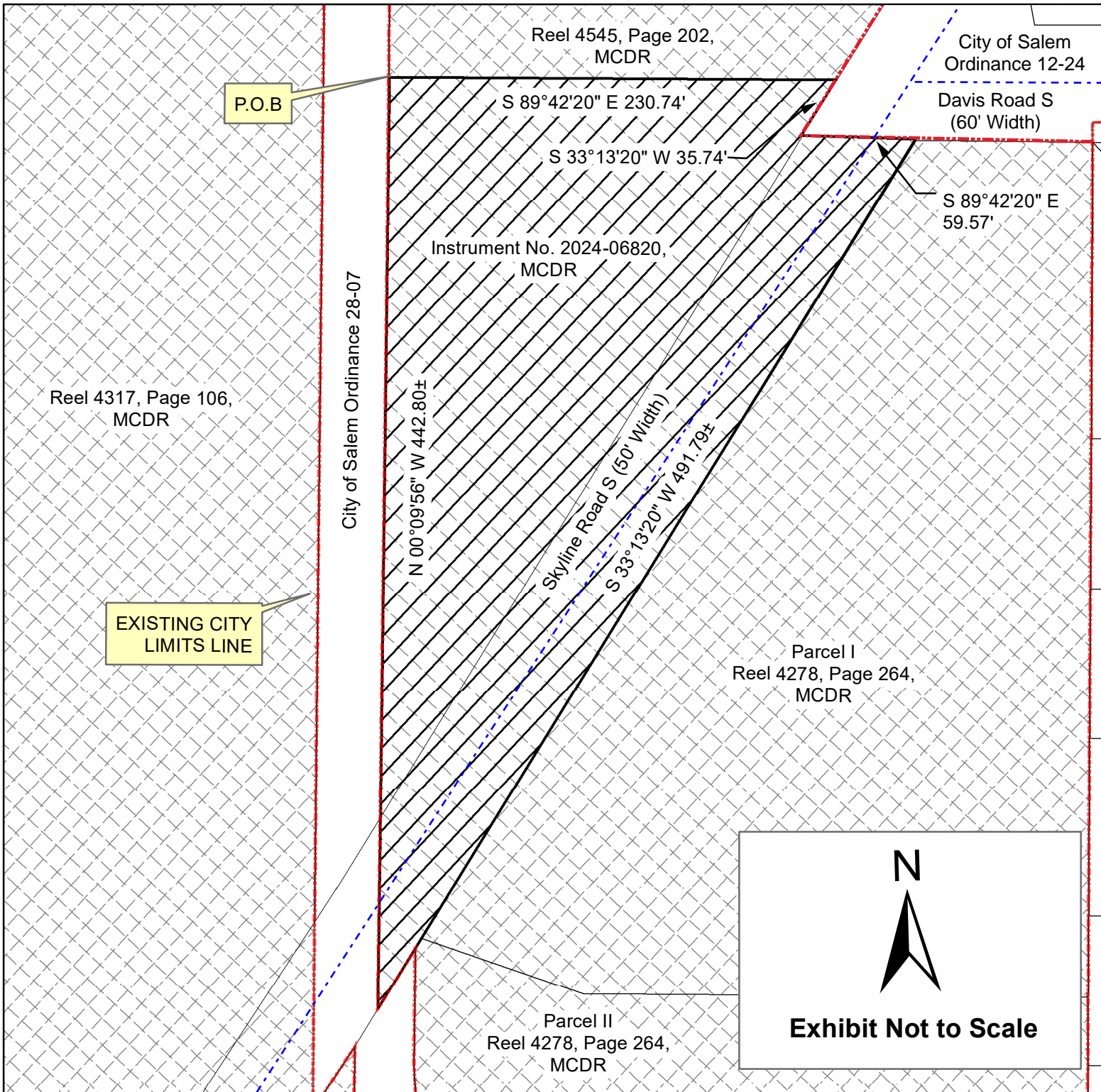
