City Council Members,

Item 5-A. I live near Ward 5 and work in Ward 3. I'm submitting this comment on Agenda Item 5-A.

Thank you for considering the Declaration of Emergency brought forward in response to the damage and terror that ICE has been bringing to our community.

It is a good start and addresses the beginning of what Latinos Unidos Siempre (LUS) asked of the Council at the last meeting.

Installing more signage, working closely with community partners (especially immigrant rights groups!), considering programs and policies to protect and support employees, and requesting more action from other elected officials is all important.

But I am, once again, disappointed with the Council's immediate leaning on "we can't do this" for so many of the requests made, if not outright ignoring them. We are in dangerous and terrifying times - times that require us to think outside of the box, to not just immediately fold over and comply in advance, but to consider how else we can make these things a possibility for our community.

For instance, the agenda discusses sanctuary zones at schools and immediately dismisses it as an impossible idea because the School District and City are separate governments. While that may be true, is there no hurt in opening communications? The City and District exist beside each other, they have other laws that impact each other, it would benefit both governments to at least \*discuss\* the potential of such. Is even discussing an idea like that between two governments - directed to be done amongst staff, not amongst governing body members - such an unheard of idea?

The same goes for the Marion County litigation. Yes, the City may not be party to the litigation, but you are all public officials with sway. You talk to other public officials, do you not? We all know that your words have power and that the City Council putting out at least a statement that they do not agree with the lawsuit, that they urge the County Commissioners to withdraw it, would do more than a nonsense statement that your hands are tied because you're not party to it. If the Mayor can attempt to impact camping laws "as a private citizen", then each of you can at least say something! Though, the City Council making a statement would be worth more.

Next, the legal memo on the Supremacy Clause makes sense. But what doesn't make sense is how law enforcement is supposed to know who are ICE agents and who are not when they will not identify themselves. Many are not wearing identifying gear, some are wearing police

vests, others are wearing "official" vests that match the ones that can be ordered off Amazon and other online retailers. Many commenters last week pointed out that trafficking cases have already been revealed under the guise of people pretending to be ICE agents (as well as some ICE agents trafficking while on the job).

So, are Salem PD just assuming that anyone who "looks like ICE" are ICE and letting them get away with any traffic violations or other crimes they see? How are they deciding who looks like ICE? Are they being communicated with ahead of time? Or, are they at least stopping people when violations are occurring and asking for identification so that they know they aren't just letting some masked assailant get away with a crime who is pretending to be an ICE agent? This whole thing crumbles and puts our community at risk because ICE refuses to identify themselves and the PD won't even try to enforce violations for fear of getting arrested. This puts us all in a deeply unsafe situation, because as the harm gets worse and the terror and fear grow, people are going to start fighting back and it's going to lead to worse and worse situations. Salem PD could do something to at least try and ease the possibility of such outcomes by investigating all violations and stepping away only when they have confirmed it is indeed federal officers, not just assuming.

Lastly, the declaration is still missing material help for our community members who have been directly impacted by ICE's actions and deportation. If your concern is where the money will come from, LUS offered one way to gain the funds by taxing Amazon - a giant corporation that pays none and assists ICE. Material help is an important part of showcasing that Salem does more than just says its cares about all of its residents, but shows that it actually does.

Please take the time to listen to your community members tonight and I urge you to move forward with the Emergency Declaration, but also consider making some important adjustments before doing so.

Dear Salem City Council,

The Marion County Democratic Party stands in unequivocal solidarity with Marion County's immigrant community. We write today to express our support of demands made by Latinos Unidos Siempre (LUS).

Our sincere thanks to Council President Linda Nishioka and Councilor Vanessa Nordyke for their motions at the last City Council meeting. We appreciate your efforts to acknowledge and address the emergency in our community created by Immigrations and Customs Enforcement.

In part, LUS is demanding that the City modify its budget to dedicate \$300,000 to those in Salem who are impacted by ICE detentions. We understand that the amount is equal in value to the city's minimum revenue guarantee for commercial airlines.

We support this investment. It is a critical support for Salem's immigrant community in a time of unprecedented crisis. We want Salem to join other cities in leading to protect their communities against federal overreach.

We believe the financial support which LUS is requesting from the City of Salem aligns with the City's Strategic Plan for Good Governance, to equitably provide services to the community; for a Strong and Diverse Economy, to address how indiscriminate immigration enforcement has caused decreased business activity and hardships in some industries; and for a Safe and

Healthy Community by helping Salem's public safety agencies keep the community safe from reckless behavior of ICE agents and residents through unlawful profiling and undue detention.

If the administration of these funds is a concern for city leadership, we encourage the Salem City Council to consider authorizing direct contributions to Pineros y Campesinos Unidos del Noroeste (PCUN) and Mano a Mano, for use in assisting families in Salem impacted by ICE.

We acknowledge the city's financial hardships that have been well-publicized. However, some projections within the City's budget are better than forecasted, like paid downtown parking revenue. There are emergency contingencies built into the City's budget. This is an unprecedented situation - Salem needs to remember its local government did the right thing for those whose lives and families are seriously disrupted by ICE detention.

Mayor Julie Hoy spoke of the Supremacy Clause in her November 24 council comments. On the issue of immigration, the more pertinent part of the Constitution is the 10th Amendment. The Amendment commands that powers not addressed within the Constitution are reserved to the states. Therefore, federal immigration enforcement must be otherwise lawful under local and state law. The 10th Amendment ensures that bodies like state legislatures and city councils are not rendered useless and ineffective for lawmaking by federal forces, like ICE.

Credible reports exist that ICE agents drive recklessly, endangering Salem residents indiscriminately. ICE violates state criminal statutes by causing property damage and using assaultive excessive force. The City Council holds Salem Police to a higher standard.

Mayor Hoy's interpretation of the Supremacy Clause seems to mean that enforcement of federal immigration laws may cause violation of state and local laws at will. While this is a very surprising position for any mayor to have, it is especially so for one that is presently engaged in petitioning a referendum to seek local control over other issues. We genuinely invite Mayor Hoy to interpret this as a local control issue as well.

In reflection of Councilor Matthews and Gwyn's comments from the November 24 meeting, the divergence is centered on whether or not ICE in our city is acceptable in the first place. We understand our immigrant neighbors to be asking for leadership in extraordinary emergencies. While it cannot be prevented, in the absence of your county peers, only you can respond.

Thank you for your time reading and your consideration of financial support for Salem's families in crisis from ICE. We hope you can find ways to agree with the items that our neighbors need. Your leadership is important.

Dear City Councillors,

Following last week's City of Salem meeting regarding ICE activities and the potential declaration of a State of Emergency, I am writing to you as a resident of Salem (Ward 8) and an immigrant of nearly 40 years.

First, I want to clarify - I support the legitimate arrest of individuals who have committed crimes and have not been held accountable. However, I believe we must reflect on our values and history during these frightening times.

The United States has been fortunate not to have faced war on its doorstep in recent history. I have family members who died in World War II; I grew up listening to 1st person accounts from both my Grandfathers who fought in the war. We must never forget, history is a reminder to stand up against persecution and targeting.

Throughout my life, I've only known of a few instances where individuals were aggressively taken from the streets: kidnappings, bank robberies, and the Holocaust. The Jewish population was deemed "undesirable" by the leader of Nazi Germany and faced persecution for simply being different. Yet even Nazi's did not hide behind masks.

I urge you to reconsider your "NO" votes from last week. Councillor Shane Matthews raised concerns about "retribution," which is exactly what those in power often seek to instill - fear in the community. I grew up just outside of London during the IRA bombings; instead of no longer going to London, we demonstrated defiance and resilience. We still went to London to prove we would not be held hostage by terroristic actions. As residents of Salem, it is our duty to stand up against the horrific actions of ICE.

If the Salem Police Department can track individuals through license plates, I ask why are they not conducting the arrests themselves, normalizing the process rather than allowing unchecked aggression from ICE.

I am also calling for transparency: please provide a list of all residents (legal or undocumented) who have been taken by ICE, including the reasons for their arrests and the subsequent plans for each individual. There is so much fear and misinformation in the community, and whole families are being traumatized....much of it due to lack of valid information.

To think we have children not going to school because they're frightened.....if those were your grandchildren, how would you be feeling? Your previous "No" votes suggest a lack of concern regarding all of these issues that will be deeply embedded in Salem long after your terms are completed.

Whilst declaring a State of Emergency may not completely resolve the terrifying actions of ICE, it would signal to the community that you care. And you stand against fear-mongering. Please do the

right thing, stand up for what is right and show the residents of Salem that you support ALL of us and will not allow our communities to be torn apart.

Thank you for your attention to this urgent matter.

I am submitting this public comment in favor of item 5a on tonight's City Council agenda, Emergency Declaration related to community impacts of federal immigration enforcement.

I was one of the dozens of people who testified over three hours at last week's meeting (many more than the "several community members" noted in your meeting agenda). I wish I could be there again tonight, but I have a cold and need to stay home.

I strongly urge you, on behalf of all those you heard from last week and the countless more who were unable or too afraid to come to the meeting, please pass this emergency declaration.

ICE is terrorizing our community. They are creating so much fear for our residents that many are unwilling to leave their homes. They are arresting anyone who is brown, with no regard to whether those people have actually committed crimes or are U.S. citizens. They are using violence as they carry out these arrests. Regardless of where you stand on the immigration process, there is no good reason for human beings to be treated this way.

Councilor Matthews said he didn't want to have an emergency declaration because he thought it might bring even more ICE activity to Salem. The truth is that ICE is already here. All of Oregon has had a target on its back since Trump took office due to our democratic governor and legislature and Portland's Black Lives Matter protests in 2020. This includes Salem. A theoretical concern that this declaration would somehow make us more of a target is NOT a good reason to take no action at all.

Councilor Matthews also said he would not support an emergency declaration because he thought it would not actually accomplish anything. However, that's not the point. It's correct that the declaration would not do all the things that community members were asking for at the last meeting. But you should still pass this resolution because it is a strong statement to our community that you support them, you do not think ICE's actions in Salem are OK, and you want to do what you can to help the community. If you don't pass the resolution, you will instead send a message that you just don't care enough about our community members to do anything.

Please help uphold the safety of our community by voting in favor of the emergency declaration.
