What prompted your interest in applying to serve as a board or commission member?

I've been advised from multiple locals to apply as I've been looking for more ways to become active in my residential community. I live in the Highland neighborhood which is often disregarded outside of the school and park. There is very poor representation at the city level of the Highland community which is diverse and has been revitalized in the past few years. I want that to continue as unfortunately there has been preferential treatment in my Ward. I want to also inspire those that might be intimated to apply or serve on committees to pursue committees that they are interested in.

Please explain how your education, professional, personal, or volunteer experience and knowledge qualify you to serve on the board(s) or commission(s) for which you are applying.

I began working for Marion County Public Health about 3 months ago as an epidemiologist. In that capacity I speak to individuals from all backgrounds such as those residing at Union Gospel Mission, individuals working with Northwest Human Services case managers, and physicians working for Salem Health. My conversations are typically disease focused as I work in the communicable disease department but they are also geared to bridging any gaps that might be apparent based on the person or disease. I also provide education with guidance primarily provided by the Oregon Health Authority (OHA) and Centers for Disease Control (CDC) depending on whether the disease. I've also had to collaborate with others throughout my department, local healthcare providers, schools, OHA, USDA, and the FDA. This is similar to working on a board or commission as we all bring different personalities but there will be times when we unanimously agree about something and times that we will compromise and also use active listening to foster adequate and efficient communication. I also spend some time training lifequards at the YMCA, connecting many to those that may be associated with their career interests and promoting a calm, safe, and enjoyable environment for (new and old) and their lifeguards. Lastly, I ran for Salem's City Council in Ward 1 which requires a lot of different elements particularly as a person that has never run for political office in Salem. The various puzzle pieces of running a campaign, meeting many different people in the political sphere, and engaging the local community are all traits that I know will help for to serve on one of the boards/commissions.

I've been a minority my entire life, but didn't experience much ethnic/cultural diversity until living in Phoenix, AZ where Hispanics are the majority. While in the environment I would go to standard grocery stores and have employees assume I knew Spanish which then forced me to learn some Spanish in order to communicate. After moving to Oregon I was thrust back into a relatively homogenous environment where much of the diversity that can be seen is heavily segregated. However living in Phoenix allowed for me to have a great interaction with a police officer that was simply patrolling the property of the local library and we had such a great conversation that help to put me (a layperson when it comes to law enformcement) in the shoes of an officer in an area with high amounts of traffic. While in college in Illinois I had to participate in diversity training as a mentor for students that were either first generation and/or from underrepresented backgrounds and that caused a chasm between students such as myself and others that looked like that were from the Midwest. At that time it was a disheartening experience, but having had years to reflect I became stronger from that activity. Today I now interact with people from different countries on a regular basis by first trying to learn how to hello in their language as that typically evokes a smile and technology can assist so communication can occur and community ties are developed.

When did you last visit the Salem Public Library? Tell us about your experience during that visit.

I last visited the library last week when I had to return items that I had forgotten to return. 've only visited the branch on Commercial St and find the librarians there to be very hospitable and helpful especially if you're new to the library. I visited the library during my campaign for City Council to count the amount of residents that were using the library. At 3pm on a Saturday 215 people not including staff were at the main library. One of my focuses throughout my campaign is that the city doesn't do needs-based assessments. I consider the library essential for communities especially once such as Salem where 45 schools had less than 5% of their students reading proficiently from 2022-2023. That's unacceptable for a community to remain productive and fully recognize that knowledge and access to it it an invaluable gift. I grew up in an environment where I could visit any library in the state and check out materials from the library without any difficulty. I've never heard about a library potentially closing until it was brought up this year. The library is a place where I typically get to help senior citizens with the printer especially if they are new to the library. It's also an area where I can see the new titles that my favorite authors(i.e James Patterson, Heather Graham, Stuart Woods) have released and allows me to check out books for hobbies I enjoy such as gardening, and creating fermented juices. Libraries allow for subjective exploration that can't be recreated anywhere else. I would love this experience to continue for the future generations and appreciate you considering my application for the Salem Public Library Advisory Board.
