Dear City Council Members:

I want to voice my concern regarding the three resolutions that you have proposed asking for an immediate ceasefire in the Gaza conflict.

I believe the Human Rights Resolution is full of inaccuracies and that the other two show a lack of understanding of the history of Gaza and what has been happening there.

First of all Gaza was given to the Palestinians as a land for peace gesture in 2005. Israeli citizens were uprooted from their homes and communities that they had built after the 1967 war. Those citizens left beautiful crops and farm land intact for the Palestinian people when they vacated Gaza--when the Palestinian Authority took over.

Two years later in 2007 the Hamas terrorist organization took over the Gaza Strip from the PA. Under Hamas the once rich Gaza Strip has been devastated and used as a terrorist hub to destabilize the area. Constant barrages of missiles daily come into Israel, killing innocent civilians in and destroying their property and farms. They have robbed the people of Gaza of money meant for humanitarian aid, building instead tunnels filled with weapons etc. right in the midst of hospitals, schools—even within them. This has been a constant since they took over. They indoctrinate Gazan children to hate Jews and teach them how to kill them. UNRWA is complicit in that they fund many of these schools. Hamas has used the Gazan civilians as human shields for too long and must be stopped. Israel is a sovereign nation fighting for its survival against those who’ve sworn to destroy them. A cease fire would only give them time to regroup and rearm and destroy some more. They’ve promised they will do another October 7.

I am asking that you not join with the other states in adopting a resolution that blames the nation of Israel for defending itself against terrorists.

Dear Mayor and City Councilors,

I know there's a very important issue before you tonight. Here are some considerations and questions:

1. Has the City taken such a position on global strife before, and will it continue to do so into the future? What criteria determines which issues get addressed, and which don't?
2. Will the passage of either resolution lead to increased safety and well-being for Salem's Jewish, Palestinian and Muslim residents? Or the opposite? My Jewish and Muslim friends are very concerned about this.
3. To what extent has the larger Salem community -- especially the community of faith -- been engaged in this conversation?
4. Why is there such urgency to pass a resolution? The situation in Gaza is urgent, to be sure, but what impact will a hastily-passed Salem resolution do to save lives in Gaza? The safety of Jews, Palestinians and Muslims in Salem should be the priority, which suggests a slower and more inclusive process for consideration of a resolution.
5. Right now, based on testimony, it seems that neither resolution is satisfactory, which indicates more work is necessary.
6. Everyone's voice is important. More weight should be given to those who are Jewish, Palestinian and Muslim. Professional advocacy is fine; personal culture, ethnicity and lived experience carries more weight. To what extent are these voices being heard and heeded?

PETITION SALEM CITY COUNCIL TO PASS A CEASEFIRE RESOLUTION

We, the residents of Salem, call upon the City Council to take decisive action to address the crisis of human rights violations and war crimes in Palestine, as local governments in nearby Multnomah, Seattle, Olympia, Bellingham, and San Juan and Jefferson counties have already done. We urge the City Council to demonstrate its commitment to human rights by passing a resolution that:

Urges the Biden Administration and U.S. Congress to call for an immediate and permanent ceasefire and unrestricted entry of humanitarian assistance into Gaza;

Calls for the restoration of access to basic necessities like food, water, electricity, and medical services to the Gazan people;

Denounces U.S. complicity in Israel’s military campaign in Gaza and the West Bank and calls for an end to all U.S. military aid to Israel, including military aid;

Calls for an end to Israeli apartheid and acts of genocide against the Palestinian people, which violate international law; and affirms the Palestinian rights to self-determination, sovereignty, and refugee return that are recognized in United Nations Resolution 3236;

Affirms the City of Salem’s commitment to support all of its residents and condemn anti-Arab racism, antisemitism, Islamophobia, and all forms of racism, xenophobia, and discrimination.

As constituents, we believe the City of Salem has an obligation to take a principled stand against injustice and promote a world rooted in compassion, equality, and respect for human rights.

Dear Members of the Salem City Council,

I am writing in support of the resolution of the Human Rights Commission regarding the current atrocities in Gaza, with a few caveats.

The attack by Hamas on October 7, 2023, which took the lives of more than a thousand Israelis, was horrific and should not be forgotten, any more than the attack on September 11, 2001 on the World Trade Center, which took the lives of more than 5000 Americans was horrific and should not be forgotten. That pain and trauma is real and will have far-lasting echoes of suffering.

While many Americans have family and friends in Israel and Gaza, we must remember that our American neighbors in here Salem, both Jewish and Palestinian, were not and are not in control of the events that have unfolded since October 2023. Those actions rest on the leaders of Hamas and Israel alone.

Together with our Jewish and Palestinian neighbors in this country – and with so many of our brothers and sisters in Gaza and Israel – we call out for an immediate ceasefire to this conflict.

I agree that the City of Salem holds as a key value compassion and is committed to promoting peace, unity, and respect for all its residents, and that we recognize and stand in solidarity with our Muslim and Jewish communities, reaffirming our commitment to their safety, security, and well-being.

However, it must be made clear that no taxpayer dollars from the Salem budget have gone to support this conflict, which is somewhat implied in the \$2,357,111 figure. In addition, every people should have the right to defend themselves.

I strongly support the resolution which stands in solidarity with our Muslim and Jewish communities, and which opposes bigotry and hate against any resident of, or visitor to, our community, which is called Salem - City of Peace - Shalom in Hebrew, Salaam in Arabic. We are one community, and I hope and pray that we will stand together for peace now, and in the days to come with the human family that is needlessly suffering now across the globe.
