What prompted your interest in applying to serve as a board or commission member?

My interest in the library board member position initially stems from my love of books. As someone who regularly seeks learning opportunities, the library is one of my favorite places. Every time I go to the library, it's a positive experience. I want to use my knowledge and capabilities to continue the positive influence that the library has on our community. In this role, I can serve as an advocate for the library's mission to engage all of Salem in lifelong learning, accessing information, and making meaningful connections. I am analytical and tend to think of the results that decisions will have two or three steps down the line. In my thoughtful approach to every aspect as a library board member, from creating policies, making budget choices, to responding to the needs and concerns within our community, I will do so pragmatically with the goal of assuring that the mission of the library is being accomplished. As a Salem resident for most of my life, I have spent many hours at the public library, and more recently, using internet-based features now provided by the library. Cultivating connections within the community is important and I feel that my relationship-based approach would allow the ability to further the mission, vision, and values of the public library, which align with my personal interests and skills. My interest in serving on the North Gateway Redevelopment Advisory Board and Citizens Advisory Traffic Commission was spurred by a recent walk I took with my family, including my four-year-old son. I have lived in the Highland neighborhood for over eight years since my husband and I bought our first home. We have always loved walking and exploring the adjacent Grant and south Keizer neighborhoods. Nevertheless, apart from walking to the State Fairgrounds, we hardly ever venture to the northeast, which is where the North Gateway Urban Renewal area begins. On this recent walk, we took Pine Street to Portland Road where the train runs overhead, and a pedestrian tunnel serves as the only route to connect to the other side, where various restaurants and food trucks are located. However, the filth and lack of investment is obvious, both pedestrian tunnel and immediate areas surrounding it, including the vacant lots, sidewalks dangerously abutting oncoming traffic, and crumbling, disused warehouses where the air wafts with a tinge of desperation and waste as if forgotten by the society around it. As someone who has lived in Salem for nearly my entire life, this is not what I want for my city. I do not want to fear taking a walk with my child to a place so near my home yet so far away in every other aspect, lacking safety, basic sanitation, and a wasting of assets. Albeit this is not to say that the entire North Gateway Urban Renewal area reflects the small stretch of Portland Road that my story centers on, but I am concerned about where Salem is now and what is in store for the future. With the recent growth experienced in Salem, there is an opportunity for traffic improvements as well. Designing more walkable areas, equitable transit systems that adequately serve the population, and safe streets are important to me. I desire for my input as a resident to be heard and utilized by decision makers to foster growth while also respecting the land and our neighbors.

When did you last visit the Salem Public Library? Tell us about your experience during that visit.

I visited the library last month on a weekday evening. As always, the library was welcoming and pleasant. I checked out a few books, after spending about an hour perusing the shelves. Usually, I frequent the library on Saturday mornings with my four-year-old son and spend most of the time upstairs in the children's area and the Discovery Room, but this time I was on my own. There is an innate quality to the library which always brings me joy, whether I am on my own or there with my family. When I approached the librarian to check out, I had a great experience. Even though I discovered that one of the books checked out under my son's card was missing, I received great customer service. I inquired about a few titles that I couldn't locate, and the librarian showed me how to use the interlibrary loan feature. He took the time to walk with me to one of the computers and show me the process. Now I know where I would go to pick it up and how it all works. Although I had been using the Libby app for some time, this was new information to me, and I found it extremely helpful considering I gained access to quite a few books on my reading list. All in all, I always look forward to a trip to the library.

Libraries build social capital, which increases the productive capabilities of the population. Building these capabilities leads to better economic outcomes for everyone. This is a basic, economics-based explanation for what role the SPL plays in making Salem a livable community, but it is true. More so, there is data showing that public libraries support building healthy communities. The SPL also helps citizens find resources and navigate unknowns of life. The library even offers special services, activities, and resources, which create openings for social connections, support, literacy and education.
