## **Recommendation:**

## Summary:

The Oregon Department of Transportation (ODOT) is planning seismic retrofit improvements to the Center Street Bridge over the Willamette River to ensure operational functionality following a major seismic event. Phase 1 of the project will retrofit the bridge and its eastside ramps, which will have impacts to Riverfront Park and Wallace Marine Park during construction. City staff have successfully negotiated an agreement with ODOT to mitigate impacts from the project on the parks, public events, natural resources, and parking. The agreement also allows the City to grant ODOT temporary easements for staging and construction access on City property.

## Recommendation:

## Summary:

In July 2025, after City Council authorization in June, the attached Cooperative Improvement Agreement (CIA) (Attachment 1) was executed with the Oregon Department of Transportation (ODOT) to fund construction of City water and fiber optic utilities with ODOT's Salem Center Street Bridge Seismic Retrofit Project. The CIA requires the City to deposit a total of \$7,000,000 for the estimated design and construction costs. The City and ODOT have negotiated the attached Amendment to the CIA (Attachment 2) revising the payment schedule for deposits to allow ODOT to proceed with pre-procurement of waterline materials prior to the construction contract to avoid construction delays due to anticipated materials lead times.

## Summary:

The current City of Salem Budget and Five-Year Capital Improvement Plan (CIP) allocates \$14.9 million for the Willow Lake Water Pollution Control Facility (WPCF) - South Secondary Clarifiers Rehabilitation Project (Project). Staff recommends a Construction Manager at Risk (CMAR) alternative contracting method to rehabilitate the four south secondary clarifiers at the WPCF. The CMAR process allows contractor involvement during the design phase to provide critical input on cost, schedule, and constructability elements that will influence and improve the design. The CMAR will be selected competitively via a Request for Proposal (RFP) process.

## Recommendation:

Adopt Resolution No. 2025-33 declaring and emergency related to the impacts of federal immigration enforcement

## Summary:

Several community members expressed concerns about U.S. Immigration and Customs Enforcement (ICE) officers engaging in conduct that infringes on the constitutional rights of members of the Salem community, including but not limited to: arresting and detaining individuals without affording due process rights; refusing to share information about the reason for an individual's arrest or the location where an individual will be detained; routinely wearing masks and refusing to provide identification; and questioning residents and visitors about their immigration status based on their race, ethnicity, language, accent, occupation, or presence at certain locations within the City of Salem. The proposed emergency declaration reaffirms City policy and its commitment to Oregon sanctuary laws and our residents affected by federal immigration enforcement.

Second Reading of ENGROSSED Ordinance No. 4-25 amending SRC chapter 38 - Salem Tourism Promotion Area (STPA) to modify the remonstrance ("objection") procedure to allow operator to file objections based on their number of available rooms.

## Recommendation:

## Summary:

The proposed engrossed (amended) ordinance modifies the system for objecting (remonstrating) to the continuation of the Salem Tourism Promotion Area (STPA). The inclusion of Accessory Short Term Rental and Short Term Rental (STR) operators has been removed from this ordinance. Enacting the engrossed ordinance will implement the modified proportional objection system, and the proposed inclusion of STRs will be brought back to Council for a public hearing in early 2026.

## **MEETING PROCEDURES**

City Council meets on the second and fourth Mondays of each month at 6:00 p.m. All meetings are in Loucks Auditorium Salem Public Library, 585 Liberty Street SE.

The Mayor, who is the presiding officer, is elected at large for a term of two years. Councilors are elected for four-year terms for each of the City's eight Wards. These nine officers comprise the Council who make the policy decisions for municipal activity and pass its ordinances and regulations.

Because the Mayor and Councilors' positions are part time, without pay, the Council appoints a City Manager who is responsible for the administration and execution of the City's policies and ordinances.

The City Council generally follows Robert's Rules of Order, but has adopted supplementary rules that may be found on the City's website at: https://www.cityofsalem.net/government/city-council-mayor/about-city-council/council-rules.

## THE CONSENT CALENDAR

The Consent Calendar allows the Council to save time by acting on everything listed on that part of the agenda with one motion instead of considering each item separately. If a City Councilor believes a matter on the Consent Calendar deserves further discussion, the Councilor can request that item be removed from the Consent Calendar and considered separately under "Special Orders of Business."

## **PUBLIC COMMENT**

There are two times at every regular City Council meeting when the public has an opportunity to address the City Council. The first time is immediately prior to the Consent Calendar. This time is reserved for questions or statements regarding items appearing on the agenda, except public hearings and the merits of land use issues. The second time is at the end of the agenda. At this time, you can address the City Council on any matter of public concern, other than an agenda item. Please sign up on the Speakers Roster prior to the start of the meeting. The Mayor will announce the time for public comment, and invite persons to address the City Council. Each person has three minutes to address the City Council. Please stop speaking when your time has expired.

Individuals that would like to provide comments during the meeting but are not able to attend the meeting in person may provide testimony virtually. To do so, please sign up online on the day of the meeting between the hours of 8:00 a.m. and 3:00 p.m. at

## **PUBLIC HEARINGS**

The City Council can hold public hearings to consider legislative, quasi judicial or administrative matters. To testify at a hearing, you may sign up on the Hearing Roster located in the lobby of at Loucks Auditorium before the Mayor convenes the meeting. At the time for the hearing on the agenda, the Mayor will announce when the public hearing is open. If you have signed up to speak, come forward to the podium when the Mayor calls your name. State your name and either your address or the ward you live in. If you wish to receive notice of any written decision reached at the hearing, you must provide the City Recorder your address. When you have finished speaking, the Mayor will ask the Council if there are any questions for you, so please remain at the podium for a moment.

The time limit for QUASI JUDICIAL LAND USE CASES are as follows:

- 1. Staff Presentation 10 minutes
- 2. Affected Party 10 minutes
- 3. Neighborhood Associations 5 minutes
- 4. Other Interested Persons 3 minutes per person
- 5. Rebuttal by Affected Party 5 minutes

The time limit is 3 minutes per person for LEGISLATIVE AND ADMINISTRATIVE

hearings. Please stop speaking when your time has expired.

The time limits for QUASI JUDICIAL HEARINGS IN NON LAND use cases are as follows:

- 1. Staff Presentation 15 minutes
- 2. Affected Party 15 minutes
- 3. Neighborhood Associations 5 minutes
- 4. Other Interested Persons 3 minutes per person
- 5. Rebuttal by Affected Party 7 minutes

Time limits for quasi judicial land use hearings are governed by Rule 19 of the Council Rules. Parties to land use cases are encouraged to review that rule as time limits vary depending on the nature of the hearing.
