- 3. Include comparative case studies of Oregon cities that have adopted renter-protection ordinances, evaluating both intended outcomes and unintended outcomes**
- 4. Evaluate the potential impacts of any renter-protection options on housing supply, housing production, development feasibility, and private investment, including available data on permitting activity, housing starts, and completions in comparable jurisdictions.**
- 5. Identify & analyze non-regulatory and supply-side strategies that may improve housing stability and affordability, including approaches that support increased housing production and preservation.**
- 6. Present options in a balanced format that allows Council to consider renter protections alongside potential economic, fiscal and housing-market impacts.**
