#### Recommendation:

Adopt Resolution No. 2320 (Attachment 1) approving SHA's consolidated operating budgets for fiscal year 2025-26 and authorize the Commission Chair to execute the HUD Public Housing **Budget Certification.** 

**Summary:** The proposed budgets are balanced and reflect funding projections based upon information provided by HUD, affordable housing industry sources, and rate forecasts of suppliers of goods and services.

> The proposed budget eliminates seven vacant positions previously funded by grants, which are no longer available.

This budget provides the resources for the Salem Housing Authority (SHA) to provide affordable rental housing to an estimated 3,700 households through various resources (Public Housing, Section 8 voucher programs, Tax Credit partnerships, and managed and/or owned properties).

The Capital Fund Program continues to permit the SHA to upgrade its Public Housing units and to make management improvements that contribute to the overall efficiency of the Authority's operations
