I think that option is watered down and cowdardly. To still be questioning whether or not what is happening in Palestine is genocide is truly disgusting. Especially considering that the city of Salem directly contributes to the deaths of Palestinian's by way of tax dollars being sent to Israel. (I am writing this from the library in which was proposed to be shut down because of the lack of funds.)

Except for the fact that Hamas would not have to exist if it weren't for the occupation of Palestine, which we do contribute to financially. So it truly does not make sense that this language is necessary other than to give the Zionists a little crumb so they don't feel "afraid". Hamas does not exist in a vaccume; if Israel has a right to self defense, then so does Palestine. But when Palestinian resistance does anything to defend themselves, they are called terrorist and antisemetic. When Israel defends themselves, it's called self defense. Re: Agenda Item 5.b: Special Orders of Business, Resolution Related to the Crisis in Gaza

Although the HRC resolution has points of merit, I do not support the HRC Resolution as it is currently written. The resolution ignores the historical context of the hostilities.

- 1. The resolution calls for the establishment of a Palestinian state without acknowledging that Hamas, the governing leadership in Gaza, is committed to the obliteration of Israel. The Hamas covenant expressly calls for this. A peaceful resolution to the conflict must call for the recognition of the free and legitimate of statehood for both peoples.
- 2. The resolution indicates that more than two million of Salem taxpayer's dollars have been used to fund Israel's atrocities. While the US is a dominant miliary provider to Israel, and US military support is unquestionably used to conduct the war with Hamas and thereby contributes to civilian casualties, the direct link of Salem taxpayer dollars to Gaza atrocities specifically, is overstated. Some US dollars fund Israeli defense. I find the language in the resolution exaggerated.
- 3. The resolution calls for cutting off US military aid to Israel. Israel has a regional military purpose that serves US interests separate from the conflict with Palestinians. The resolution should have recognized the broader context.

I support the superior City Manager Resolution which better promotes peace and unity.

## Mayor Hoy, Councilors, et al:

As a member of the Jewish Community of Salem, and as a Lebanese Jew, I am deeply concerned about::

- the intent of this resolution
- the impact on the Jewish Community of Salem
- the trauma experienced by Jewish community members at the HRC hearings on the topic of the resolution
- the lack of genuine interest in meaningful engagement with the Jewish Community by the City Council and staff

If we are to assume the best of intentions by the City Council and staff, when directing the HRC to develop a recommendation for the City Council to pass as a formal statement reflecting the community of Salem, then as a Jew, I can overlook some of the missteps taken to get where we are today. However, the totality of the circumstances sends a clear message of antisemitism, regardless of how many times you decry antisemitism and hate.

- During Passover, a period when many Jews are not engaged in social media but are focused on religious contemplation and celebration, you directed the HRC to begin taking public testimony on this topic.
- The HRC extended the period of public comment to allow observant Jews to participate and offer input. However, at that public event, a Palestinian flag was displayed at the front of the venue, and when members of the Jewish community requested the removal of the flag, we were told by City staff that it was not allowed to be removed. Remote participants were frequently off screen, while their screens displayed the Palestinian flag and pro-Palestinian statements, to the viewers. This apparent HRC-sanctioned activity was not only traumatizing to Jewish community members, but it also created an atmosphere that appeared intentionally designed to chill comments from anyone with a perspective that did not support that of the overwhelmingly Ward 1 individuals who only gave first names and wore masks and other face coverings. How do you know that you were actually hearing from Salem residents?
- During Jewish History Month, you are adopting a resolution that does not appear to support Israel's right to exist, does not reflect acknowledgment of Israel and its environs as the indigenous homeland of the Jewish people, and indicates Israel is fighting against Palestinians not Hamas, a theocratic and violent terrorist organization. The resolution does not recognize Israel as one of the few democracies in the Middle East nor does it acknowledge the homophobic, anti-Semitic, and misogynistic agenda of Hamas, the de-facto and illegally seized government of Gaza.

In my professional life, I routinely make City Council and Commission presentations

throughout the state. The experience I had at the HRC ranks among the least civil and unbiased I have had at any other public meeting during my decades-long career in civil rights and anti-poverty work. I will not be at the City Council meeting tonight, as I do not wish to relive the same experience I had at the HRC meeting.

I urge you to discard your plan to adopt a resolution unless and until you have done more work to truly understand all of the issues involved and to craft a resolution that actually reflects the input of the Jewish community.

#### Comment for Public Record

Dear Mayor Hoy and City Councilors:

You have before you tonight a Resolution from the Human Rights Commission of Salem that should be voted down. Many of the statements are ones that all serious people can agree on. We all hope for the day when both sides lay down their swords and turn them into plowshares. The language of the Resolution goes too far, however, accusing Israel of "atrocities" and in the cover letter quoted in *Salem Reporter* accuses Israel of "genocide" in its operations against Hamas in Gaza. In so doing, it turns truth on its head.

Genocide is defined as, "The deliberate and systematic destruction of a racial, political, or cultural group." Genocide is Nazi Germany, Rwanda, Cambodia. Millions were hunted down and systematically destroyed because of their racial, political, or cultural identity. That is not what Israel is doing in Gaza, but ironically is the express goal of Hamas as stated in its in its own charter. When Hamas says that it wants to free Israel "from the river to the sea" it means no less than the total destruction of Israel. Dear Salem City Council,

Today, the city council will vote on whether to pass a resolution on Gaza.

I, Rabbi Avrohom Perlstein, have voiced my opinion and the opinion of the majority of Jews. Yet the HRC and the Mayor have not listened to our voices. My points so far have been addressing the unfortunate 337% rise in antisemitism since October 7<sup>th</sup>. But before you decide to vote on this resolution, I'd like to address the falsehoods of it.

The resolution addresses the Israeli government and its war with Hamas as if they are fighting the Palestinian people. It also makes the claim that Israel is deliberately targeting civilians.

This is today's blood libel of the Jewish state/Jewish people. It is simply not true. The IDF has never deliberately targeted any civilians. The ongoing war is targeting Hamas, who has built a terrorist stronghold within a civilian

population to cause as much harm as possible to their own population. It is recorded for all to see how the IDF has gone to great lengths to protect civilian casualties while faced with unprecedented challenges in fighting Hamas.

The resolution seems to believe that Israel is hindering humanitarian aid from entering Gaza. This too is comepletly false. Israel is sending in more trucks now into Gaza then it did prior to October 7<sup>th</sup>. Hamas is stealing trucks each day and they are killing their own people while doing so. This said, the equating of the "Palestinian" people, which should be worded as Hamas, and the Israeli government is a false moral equivalent. That they are both committing terrorist acts is a grotesque comparison and wording. The Israeli government is a democracy which holds its own accountable for crimes committed. The PLO, Hamas, and all other current governing bodies of the Palestinian people celebrate each time an Israeli is killed. Still today, over 70% of the Palestinian people living in the West Bank and Gaza support the genocidal attack by Hamas on civilian life on October 7<sup>th</sup>. The majority of Israelis do not support any attack on civilian life.

The 2 million of taxpayers' dollars that Salem citizens give towards our allies in the Middle East is a drop in the bucket of what anyone in Washington is going to address. Besides, arguing that we need to address the funds given to Israel and not address the funds that go to Hamas is also uneducated and not based in reality. UNWRA, which has been proven to be a front for Hamas, receives billions in taxpayers' dollars each year, and for the past 20 years much of that money has gone directly to harm Palestinian and Israeli civilians.

So, again, if this truly was about human suffering, why is the city turning a blind eye to what Hamas and the Palestinian people do and only call out Israel, or what Israel is receiving?

Thank you to the members of the Salem / Salaam City Council for allowing us to submit our request for approval of the Human Rights Commission version of its Ceasefire Resolution, that specifically calls out the tragedy there for what it is: a Genocide.

My name is Sarah El Ebiary, I am an attorney and the President of the Oregon Muslim Bar Association. I live in West Salem, was born and raised in Oregon and am the only member of my entire extended family born in the United States. My family immigrated to Oregon from Egypt, and I am very proud to be an American. I love this country dearly for our equal rights, freedoms, and democracy. My father was a surgeon in the US Air Force and after serving our country, he retired back to Oregon where he worked at the State Hospital and here at Salem Hospital while I was in high school and college until he passed away after my junior year at OSU.

I remember he always used to tell me not to get too stressed out about what was happening over there, because there's really not much we can do about it from here, and we must continue to go on with our lives.... in peace.

Well, as the stubborn daughter I was born to be, as usual I disagree in that we should be able to think or speak out when our hands cannot change things ourselves. I believe in representation and advocacy, so I am here today to share some stories with you all.

I can't live in peace seeing images and videos of real Palestinian children being starved, beheaded, and slaughtered by Israeli bombs paid for by our tax dollars, including over \$2.3 million of Salem taxpayers' dollars that are estimated to annually have been used to fund Israel's atrocities on Gaza.

What did or didn't happen on October 7th is never justification for the genocide unfolding there. It is not OK to displace thousands of civilians to a densely packed so-called safe zone and then bomb it indiscriminately, after the ICJ ordered Israel to stop the attacks, unless it was deliberately planned that way. It is not OK to annihilate all of these men, women, and children and then just call it a mistake common of the war.

IDF admits to shooting their own citizens and provides video evidence from their own helicopter, tank, and body cam footage. This was reported in HAARETZ.

What's not being reported are the lies of headless Israeli children while the truth of beheaded Palestinian children is online for all to see. May the beheaded babies of Rafah haunt you Genocide deniers forever.

What's also not being reported are that the massacres are occurring to clear out the area towards building access to the natural gas and oil reserves under Gaza with an alternative trade channel to the Suez Canal. Unfortunately, there's over a million Palestinians living in the way of the west's plans for economic dominance over Russia and China.

These wars have been going on for longer than we can remember. My uncles fought in the 6 day war and remain very nationalistic.

I have family currently living over there in Palestine, 47 people all huddled in one apartment together, and I check daily for their social media posts. Thankful to see updates that 1, they're not dead yet and 2, they still have internet or electricity.

I asked them how I can help or if they needed anything, and I was told, No we're OK. It's just another war. Pray for us.

We love you. It happens all the time.

It's just another war...

My mom's cousins who have lived in PALESTINE for decades would tell us the most infuriating stories that I grew up hearing, about how one day in the 80s my cousin Tarek went to a grocery store and came back to find his entire house bulldozed to the ground. Thankfully, they only lost their material possessions but retained the land and began to rebuild immediately. Rachel Corie wasn't as lucky.

We sometimes got together in Egypt whenever the border crossing would be scheduled to open briefly, so one of their family members could travel for medical procedures as not only were they not allowed to use the hospitals in Israel, they were not even allowed to step foot over the border of apartheid Israel, which is not and never was a country with the equal rights, freedoms, and democracy we take forgranted here in the United States.

I was just a child but I remember the posters in my young cousin's bedroom in Egypt. The only words in English reading:

PLO, Israel NO!

He grew up to be a pediatrician in Gaza and refuses to leave now. He would rather die a martyr helping children and families than to evacuate as a burden on a foreign country's resources.

My other cousin Omeyma, a very beautiful and a regionally famous local news anchor and eventually had to end her journalism career when their television station was bombed by the occupation forces. The ultimate goal was censorship so that it no longer exists and so that the narrative of regular citizens can be suppressed and controlled. A true democracy protects Freedom of speech and Freedom of the Press. Israel, NO.

My cousin always wanted a family and was unable to have children of her own due to the toxic environment there. She loves me like a daughter and eventually went on to become a teacher with a room full of children of her own. She now lives in Europe with her convert Belgian husband and they're fundraising to get the rest of her family and inlaws out safely.

She told us each person's travel fee to evacuate from Palestine is over \$8,000 US Dollars, which is an insanely high bribe to ensure that human smugglers are not going to rip them off and run off with their cash. All banking there is forbidden, there's no PayPal, and these GoFundMe's are often hard to trust.

What people fail to Realize here in the US is that there are many different types of people still stuck in Gaza, not just Muslims or Palestinians but also Christians, Atheists, indigenous natives, Americans, Europeans, Asians, Africans, and everyone living there just wanting to go to school, work and support their families so they can continue to go on with our lives.... in peace.

These are "normal" people. They're not terrorists. They don't want this. They may seem sometimes numb to the endless wars as it happens all the time. But this time is not just another war... it is a Genocide.

Over half of the population there did not vote for HAMAS.

My family does not support HAMAS.

Christians did not vote for HAMAS, and they too should be named in this Resolution before we lose what's left of the indigenous descendants of Jesus Christ Himself.

The people in the West Bank do not even live with HAMAS, which is just in Gaza.

So why is everyone there suffering under the regimes of these oppressors?

One of which is supposed to be the most democratic ally of the United States, inflicting collective punishment paid for by our tax dollars?

Why are we seeing the slaughter and destruction of women and children and babies and hospitals and universities and bakeries and ambulances and refugee tents and war crime after war crime without US media acknowledgement or legal accountability, or news retractions of fake victims claiming rape, beheaded babies, put in ovens, and other LIES that have been debunked despite the outcries of the ICC, ICJ, UN, and International Community?

We are actually funding the starvation and deaths of all their own hostages that no one on their side is even trying to release.

We are watching live on Social Media the ethnic cleansing, famine, ecocide, mass graves, and displacement of an entire population, yet again...

So either we ignore all that suffering because there's not much we can do about it, other than voting, boycotting, learning about US tax structure, calling out AIPAC sponsored politicians like Ron Wyden, Maxine Dexter, and for allowing foreign interference to dictate our government or

running for office ourselves, changing legislation and foreign policy...

Or

the least we can offer here today from Salem, Oregon is a call for an immediate ceasefire

resolution.

So if there's really not much we can do about stopping the war from here, let's at least make this call as in the namesake of our city SALEM/Salaam, so that we can try to continue to go on with our lives.... in peace.
