ADMINISTRATIVE RULE SUMMARY

The proposed administrative action to be taken is to adopt Administrative Rule 109-200 System Development Charges.

The purpose of the proposed rule is to provide a clear and consistent practices applicable to collection, expenditure, and reimbursement of system development charges. Elements of the proposed rule include:

- Definitions
- Expenditure policies regarding projects providing additional capacity
- Criteria for adding or deleting eligible projects
- Limitations for reimbursement to developers
- Eligibility ratios for various types of projects
- Fee collection policies
