3.2a. 21-377 Collective Bargaining Agreement between the Salem Housing

Recommendation:

Approve a three-year collective bargaining agreement between the Salem Housing Authority (SHA) and American Federation of State, County and Municipal Employees (AFSCME), for a period from July 1, 2021, through June 30, 2024.

Summary: The Salem Housing Authority (SHA) began negotiations with American Federation of State, County and Municipal Employees (AFSCME) on February 8, 2021, for a successor collective bargaining agreement. A final tentative agreement on a three-year contract was reached during bargaining on July 12, 2021. The employees represented by AFSCME ratified the agreement on September 10, 2021.

Purchase and Sale Agreement for Southfair Apartments and transfer of the Housing Authority Payment contract associated with Southfair Apartments to the Yaguina Southfair Housing Limited Partnership

Recommendation:

Approve Resolution No. 2279 authorizing the Salem Housing Authority to take all actions necessary to close on conveyance of the Southfair Apartments and transfer of the HAP contract associated with Southfair Apartments.

Summary: Conveyance of the Southfair Apartments and transfer of the Housing Authority Payment (HAP) contract associated with Southfair Apartments from the Southfair Housing Limited Partnership to the Yaguina Southfair Housing Limited Partnership will allow SHA to combine the Southfair Apartments with the proposed Yaquina affordable housing development for purposes of financing. This partnership will provide funds to support a renovation of Southfair Apartments and addition of two fully ADA accessible units where the daycare used to operate. This process will also allow the partnership to construct 52 new units at Yaguina Hall that will assist in housing individuals with Serious and Persistent Mental Illness.

Summary: The proposed budgets are balanced and reflect funding projections based upon information provided by HUD, affordable housing industry sources, and rate forecasts of suppliers of goods and services.

> This budget provides the resources for the Salem Housing Authority (SHA) to provide affordable rental housing to an estimated 3,700 households through various resources (Public Housing, Section 8 voucher programs, Tax Credit partnerships, and managed and/or owned properties).

The Capital Fund Program continues to permit the SHA to upgrade its Public Housing units and to make management improvements

that contribute to the overall efficiency of the Authority's operations.
