<u>Summary:</u>

In November 2021, an Intergovernmental Agreement (Attachment 1) and Purchase and Sale Agreement (Attachment 2) were executed with the City of Turner for a new water pump station to supply Turner's water system from Franzen Reservoir, and to transfer ownership of the pump station and real property to Turner upon completion of the project. Design and construction costs have escalated from an estimated cost of \$1 million to approximately \$1.5 million due to supply chain issues and inflationary impacts. Salem and Turner have agreed to generally split the unanticipated additional costs and to extend the completion dates with the attached amendments to the Intergovernmental Agreement and the Purchase and Sale Agreement. 3.3b.

<u>Recommendation:</u>

Authorize the City Manager to accept and execute all documents related to the DLCD IGA #21066-2 which supports the required five-year rewrite of the Salem Natural Hazards Mitigation Plan last adopted in January 2018.

<u>Summary:</u>

The City of Salem has a Natural Hazards Mitigation Plan (NHMP) that describes its risk to natural disasters, such as floods and earthquakes, as well as mitigation strategies and tasks to reduce risk. NHMPs are required by the Federal Emergency Management Agency (FEMA) to be eligible for pre-disaster mitigation grant funding-such as a past funding award for pre-disaster seismic upgrades to fire stations and 2012 post-disaster mitigation grant funds for enhancements to the Mill Creek Flood Early Warning System.

NHMP's are required to meet the stipulations of 44 CFR 201 and are submitted to Oregon Department of Emergency Management and FEMA for approval of plans that are awarded for a five-year period, after which the plan must be updated and re-approved by FEMA to remain eligible for the above mentioned pre and post disaster funding.

Hazard mitigation planning and actions provide for a more resilient city. Staff planners from across the city departments meet on a regular basis to review action items and determine any interim plan changes needed.

The Oregon Department of Land Conversation and Development has received a primary award of funding from FEMA; however, this requires a 25% cost share from the City that can be provided through cash, in-kind, or a combination of both. The term for the services agreement ends on March 14, 2025.

MEETING PROCEDURES

City Council meets on the second and fourth Mondays of each month at 6:00 p.m. All meetings are in the Council Chambers, Room 240, 555 Liberty St. SE.

The Mayor, who is the presiding officer, is elected at large for a term of two years. Councilors are elected for four year terms for each of the City's eight Wards. These nine officers comprise the Council who make the policy decisions for municipal activity and pass its ordinances and regulations.

Because the Mayor and Councilors' positions are part time, without pay, the Council appoints a City Manager who is responsible for the administration and execution of the City's policies and ordinances.

The City Council generally follows Robert's Rules of Order, but has adopted supplementary rules that may be found on the City's website at: http://www.cityofsalem.net/Pages/council rules.aspx.

THE CONSENT CALENDAR

The Consent Calendar allows the Council to save time by acting on everything listed on that part of the agenda with one motion instead of considering each item separately. If a City Councilor believes a matter on the Consent Calendar deserves further discussion, the Councilor can request that item be removed from the Consent Calendar and considered separately under "Special Orders of Business."

PUBLIC COMMENT

There are two times at every regular City Council meeting when the public has an opportunity to address the City Council. The first time is immediately prior to the Consent Calendar. This time is reserved for questions or statements regarding items appearing on the agenda, except public hearings and the merits of land use issues. The second time is at the end of the agenda. At this time, you can address the City Council on any matter of public concern, other than an agenda item. The Mayor will announce the time for public comment, and invite persons to address the City Council. Each person has three minutes to address the City Council. The time light on the podium will flash yellow when you have one minute left, and will turn red when your time has expired.

HOW TO GET YOUR COMMENTS INCLUDED AS PART OF THE AGENDA

Any written comments that you wish to be given to the City Council that are about an item on an agenda must be submitted to the City Recorder by 3:30 p.m. on the day of the City Council meeting when the item will be considered. If you have some matter that you wish to have the City Council consider in the future, you are encouraged to submit your suggestion in writing to the City Manager at 555 Liberty Street SE, Room 220, Salem, OR, or by e mail to: manager@cityofsalem.net.

PUBLIC HEARINGS

The City Council can hold public hearings to consider legislative, quasi judicial or administrative matters. To testify at a hearing, you may sign up on the Hearing Roster located near the east entrance to the Council Chambers before the Mayor convenes the meeting. At the time for the hearing on the agenda, the Mayor will announce when the public hearing is open. If you have signed up to speak, come forward to the podium when the Mayor calls your name. State your name and either your address or the ward you live in. If you wish to receive notice of any written decision reached at the hearing, you must provide the City Recorder your address. When you have finished speaking, the Mayor will ask the Council if there are any questions for you, so please remain at the podium for a moment.

The time limit is 3 minutes per person for legislative and administrative hearings. The time limits for quasi judicial hearings in non land use cases are as follows:

- 1. Staff Presentation 15 minutes
- 2. Affected Party 15 minutes
- 3. Neighborhood Associations 5 minutes
- 4. Other Interested Persons 3 minutes per person
- 5. Rebuttal by Affected Party 7 minutes

Time limits for quasi judicial land use hearings are governed by Rule 19 of the Council Rules. Parties to land use cases are encouraged to review that rule as time limits vary depending on the nature of the hearing.
