My mother-in-law lives in SalemTowne, and I am writing as her advocate to attempt to ensure her safety, and the safety of her senior neighbors.

Please do not place a homeless settlement next to our fragile seniors.

To whom it may concern,

I wish to provide comment on the following agenda item:

Allowing managed temporary camping for the homeless and emergency shelters as temporary uses

The proposed site for temporary housing is at the intersection of Brush College Rd NW and Wallace Rd. I am concerned about moving a population of 50-60 residents miles from the agencies on which they rely for support. Are they planning to walk the 4 miles to get to services? Or ride their bikes? Crossing Wallace road to access the bike path is a dangerous proposition. Does the city plan daily transportation for those residents?

This project is marked as managed, who is managing it? How much of the proposed \$90k+ in operating costs is earmarked for staff to provide services and support to residents? Or is it solely for maintenance and upkeep? Statistics show that the unhoused experience higher than normal rates of substance abuse and mental health. Is the City providing intervention for drug use or mental health?

Has the City talked to legal counsel regarding liabilities? For example, pedestrian/cyclist/auto accidents and injuries due to proximity to the busy Wallace corridor or crimes in camp or surrounding neighborhoods resulting from the aforementioned substance abuse and mental heath issues.

These concerns are exacerbated by the proposed camp's proximity to nearby elementary schools.

Having witnessed (as many of us have) the damage caused by camps, I worry about the increased debris and litter in the surrounding countryside and environmental damage, pollution, its effects on area wildlife, the water and soil.

I fully support efforts to lift up the unhoused by providing access to housing, employment and healthcare, but I strongly question this move. I fear it merely displaces the unhoused to another location without offering a holistic and thoughtful solution.

Has anyone reached out to churches and faith leaders for partnerships? There are numerous churches in the downtown area, near services utilized by the unhoused, with empty parking lots and armies of attendees with a mandate to help their fellow human. At each location is a building with bathrooms, is heated when it's too cold and air conditioned when it's too hot...

and empty all week long. Folks at each church could work on rotation to provide a more complete support network for just a few shelters per location. With this additional support and community involvement, you may be able to put more of the budget for this project into shelters rather than operating costs, getting more off the street. If successful, each church may feel compelled to continue the good work in perpetuity.

In the past 18 years I've helped create programs to help people transition off the streets, and to meet their basic human needs, as well as helping youth and families break free from generational poverty. I'm concerned over the proposed West Salem Homeless Camp. My main concern is the lack of resources and adequate support in West Salem. Without easy access to support, such as UGM and Arches, and other programs people will be forced to find what they can on their own; and without access to resources they will be put into a position whereas they have to take in order to survive. This should be an obvious concern to all involved. It would set struggling people up to fail. A West Salem location is not in the best interest of those it's intended to help. A camp located within easy walking distance to UGM, HOME and Arches is a wiser choice, and I'm perplexed that the Council would even consider the site void of the basic services that are needed to support the the homeless population. I read about the proposed temporary housing for the homeless on Wallace Road in West Salem.

While I would like to find more solutions to alleviate the problem of homelessness in Salem, I have serious concerns regarding this project.

I request that this item be tabled for this month.

Additionally, I humbly request that you please present a report to the West Salem Neighborhood Association meeting about the facts and realities of this type of project and how it fits in the city's overall plan. If it has been presented before, please do it again. Many more people are now listening, and you would have an opportunity for greater buy-in, so to speak, from more of the community.

There has been lots of online discussion this weekend with opinions across the spectrum. Some good questions that were posed include:

- It's stated that it is a temporary camp. How long is temporary?
- Who will staff this area and keep it safe and sanitary?
- How will it be managed so there is no camp overflow into the park and ride lot?
- Who will provide the medical and social services that people need? These services aren't located in this area.
- We know crime, harassment, trespassing and sanitation issues increases around homeless camps. How will the surrounding community be kept safe?
- How will the \$96,000 per month be spent? At \$1600 per resident, where does that go?

Some neighbors shared: "In the last two years we have had encounters with homeless people who seemed mentally unstable and it's concerning. How do we know we won't be opening our neighborhood to more of this? Please consider these questions and consider the suggestions for other properties that are not within a neighborhood."

Again, I ask you to remove the item from tonight's agenda to allow more factual information to be shared that we may better work together to find some solutions. Thank you for your consideration.
