Dear Mayor Bennett and Councilors,

I appreciate all the time and consideration you are putting into a new bond measure for the Police Facility and seismic upgrades, as well as your outreach to Salem residents regarding the planning process.

I understand that staff was directed to come back with plans for three possibilitiesthe larger and smaller stand alone Police Facilities, and one that includes both seismic upgrades to the Library and City Hall as well as a fair amount of renovation to those buildings.

I see that a very important option is missing- a reasonable, carefully budgeted police facility and ONLY seismic upgrades to Library and City Hall. Unless that option is also studied, you are missing out on what many of us think is the most easily passed bond measure. I suspect that some of you think it was only the cost of the bond that drew no votes last time around. I believe that it was as much or more the lack of seismic upgrades that caused it's failure, and will again.

How can you move the police out of an unsafe building and not fix it for those who need to stay and work there, as well as the children and families who use the library? The school district is figuring our how to do seismic upgrades on all the buildings most in need. How can the city not do the same? This is your chance!


MONDAY NIGHT: A PROPOSAL FOR A NEW POLICE FACILITY BOND WE CAN ALL GET BEHIND

Monday night at the the City Council meeting, Salem Community Vision will present its new "Plan B" bond measure proposal. It would fund a 115,000 square foot police facility plus seismic upgrades of City Hall and the Library for \$66.3 million. This is \$15,700,000 less than the \$82 million dollar bond measure that was defeated last November. It is based on police facility costs that are comparable to the new Beaverton police facility that voters there approved last November. But this plan would also save hundreds of lives in the Library and City Hall when the next Cascadia earthquake hits. The police facility cost is lower than any of the options that the City staff is proposing, and two of those do nothing to save lives at City Hall and the Library. We think this is a plan that everyone can get behind in a May, 2017, election.
