

ALTERNATIVE COSTS MAJOR POINTS

CONSTRUCTION COST REDUCED SLIGHTLY FROM \$299 TO \$270

POLICE CARS ON PARKING STRUCTURE DECKS REDUCED FROM 100 DOWN TO 50

DEVELOPMENT COSTS REDUCED FROM 13.75% TO 12.75%

SOLAR, ART, FF&E, CONTINGENCY, ARE PERCENTAGES OF THE G.C. CONTRACT AMOUNT

ESCALATION 3.5% INSTEAD OF 9% IF WE SIGN A G.C. CONTRACT BY END OF YEAR (DEC)

CONTINGENCY REDUCED FROM 9% TO 5% (LIKE BEAVERTON)
