## END NOTES TO CHANGE ORDERS:

**1. Change Order No. 1 adds \$463,889:** Provides for the commissioning of the mechanical and electrical systems; and the programming and schematic design process to expand the size of the building from 30,000 square feet to 50,000 square feet to include the Engineering Division and provide additional program elements such as expanded locker rooms, additional conference rooms, and areas for future growth.

**2. Change Order No. 2 adds \$28,391.65:** Provides for poor subsurface conditions discovered during paving. The poor subsurface conditions required additional excavation and 12 inches of additional compacted aggregate below the 6 inches of aggregate required.

**3. Change Order No. 2 adds \$50,000:** Provides for the anticipation of additional projects needing to take place this year.

**4. Change Order No. 3 adds \$113,000:** Provides for all planned projects, potential projects still in the vetting stage, and unanticipated requests.

**5. Change Order No. 4 adds \$200,000:** Provides for additional funds needed to extend the contract until June 30, 2022.

The not-to-exceed contract amounts are competitively set by applying bidder's/proposer's per unit price(s) to estimated annual requirement quantities.
