4120 Fisher Road NE and Adjacent Lands

All that real property being described in Reel 4248, Pages 357 and 358, Marion County Deed Records, and that land lying within the public right-of-way of Fisher Road NE, situate in the Northwest One-Quarter of Section 7, Township 7 South, Range 2 West, Willamette Meridian, Marion County, State of Oregon, and being more particularly described as follows:

Beginning at a point of intersection of the North Line of the land described in Reel 4248, Page 358, Marion County Deed Records, and the East right-of-way of Fisher Road NE, said point being 25.00 Easterly from the centerline of said road when measured perpendicular thereto, and lying on the Now Existing City Limits Line;

Thence along said North Line also being coincident with the South Line of Fisher Gardens Townhomes P.U.D., Marion County Book of Town Plats, and the Now Existing City Limits Line, North $88^{\circ}39'41''$ East, 498.55 feet to the northeast corner of the land described in said Reel 4248, Page 358;

Thence leaving the Now Existing City Limits Line, South $00^{\circ}39'33''$ West, 388.77 feet along the East Line of the lands described in Reel 4248, Pages 358 and 357, Marion County Deed Records, to the Southeast corner of the land described in Reel 4248, Page 357, said corner lying on the North Line of the Cooley Subdivision, Marion County Book of Town plats;

Thence along the South Line of the land described in Reel 4248, Page 357 also being coincident with the North line of Cooley Subdivision, Marion County Book of Town Plats, South $89^{\circ}13'41''$ West, 291.50 feet to the Southeast corner of Parcel 2, Marion County Partition Plat No. 2007-148;

Thence along the East Line of said Parcel, North $00^{\circ}04'19''$ West, 84.08 feet to the Northeast corner thereof;

Thence along the North line of said partition plat, and westerly extension thereof, South $89^{\circ}13'41''$ West, 252.00 feet to a point on the west right-of-way line of Fisher Road NE as surveyed in September 1993, Marion County Survey Record 33191;

Thence along said West right-of-way the following 3 calls:

North $00^{\circ}04'19''$ West, 119.35 feet to an angle point in the Now Existing City Limits Line also being the point of intersection of said west right-of-way, and the most Northerly, South line of the land described in Reel 2556, Page 401, Marion County Deed Records;

North $00^{\circ}04'19''$ West, 59.61 feet along the Now Existing City Limits line, to an angle point therein, also being the point of intersection of said west right-of-way, and the most Southerly, North line of the land described in Reel 1045, Page 368, Marion County Deed Records;

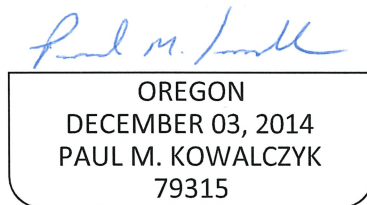
Leaving the Now Existing City Limit Line, North 00°04'19" West, 120.22 feet to a point on the Now Existing City Limits Line, also being a point of intersection of said west right-of-way and the westerly extension of the North Line of the land described in said Reel 4248, Page 358;

Thence along the Now Existing City Limits Line also being the said westerly extension line, North 88°39'41" East, 50.00 feet to the Point of Beginning.

The above described property contains 3.98 acres of land outside the existing right-of-way of Fisher Road NE and 0.37 acres within the existing right-of-way of Fisher Road NE.

The Basis of Bearing for this description is North 0°14'19" West along the centerline of Fisher Road NE between station 29+77.58 and station 36+42.81 as depicted on Marion County Survey Record 33191.

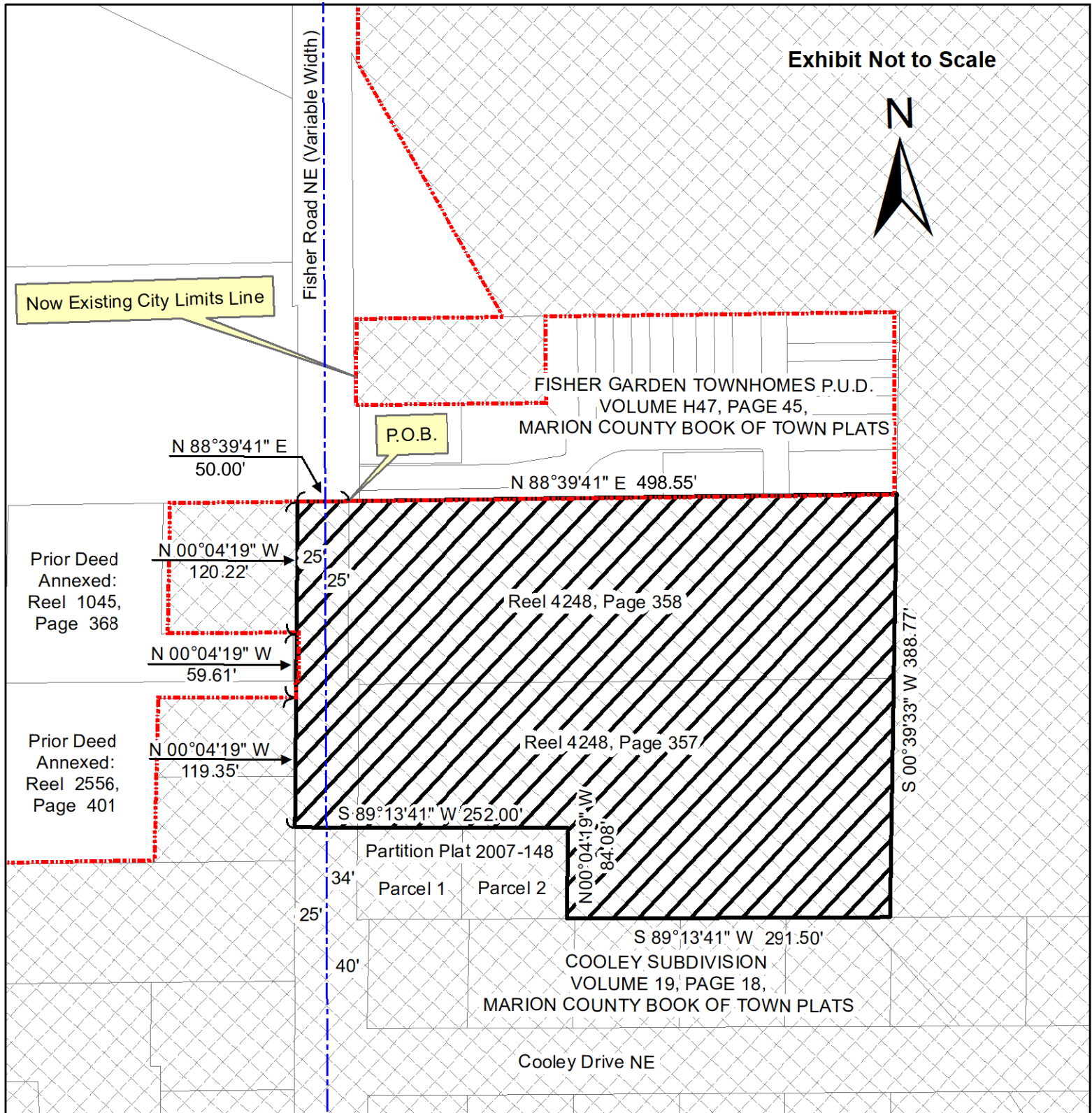
