

Comments on Interactive Map

Alternative 1	
Name	Comment
Not provided	This seems acceptable
Bill Dixon	I prefer Option 1 with one adjustment: Add Riverfront Park to the ward. That would put Minto Brown Island Park and Riverfront Park, which are united by the Courtney Bridge and serve many of the same users, in the same ward, without changing population.
Ted Stonecliffe	Alternative 1 is the most equitable shape for Ward 2. Both alternatives 2 and 3 include all of the city north of OR-22 east of Lancaster Drive. This is arbitrary and creates an unnatural divide between Wards 2 and 3, so I prefer Alternative 1.
Charlotte Vollet	We prefer Alternative 1 as we would like to remain in Ward 2. It is a natural divide along Madrona and keeps us in the Ward occupied by Willamette University and the hospital.
Not provided	This option seems the most reasonable and aligns the Edgewater business with the Downtown business district. This option will allow "like areas" with similar concerns and issues a unified voice in representation.
Not provided	I feel that Ward 8 should incorporate ALL of West Salem and include the portions of Ward 1 that are West of the river. Currently West Salem is served by 2 wards and (01 and 08) and feel it would be better served by one councilor.
Norine Ask	This seems totally business, not people-oriented. NE Salem has a lot of low-income families whose interests do not align with the W Salem businesses or population. This weakens the already limited power of the less fortunate in Salem.
Marilyn Moritz	While I see that the population for this ward deviates from the target, I hope that the Council takes into consideration the development that will add at least 500 residents to this neighborhood very soon (Ward 6).

Alternative 2	
Becky Beaman	It makes sense to me, as a Ward 7 resident, that Minto Island Park be part of Ward 7. It is reached by land from Ward 7, not West Salem. The carveout at the north end here looks contrived. Very few residents in this slice -- why combine with WS?
John	This proposal for Ward 4 appears to violate the rule that wards be contiguous, with the small section of 36th Ave SE between Kubler and Boone being surrounded on 4 sides by Ward 3.
Not provided	Ward 8 should include everything West of the river and exclude Ward 1. Ward 1 should include portions of ward 2 and 7 to make up the difference in population.
Andrew Earls	I like this one the best. I noticed we are not increasing the area of the city. I would like to know how we would propose extending ward 6 down to center st. Would that help at all?
Stephen Stover	This mapping system is designed for professional planners. West Salem residents, more than any ward in the city, are isolated and share a common interest.
Alternative 3	
Mike Hughes	<p>Alternative 3 seems to be the closest to ideal but the following changes would improve it:</p> <ol style="list-style-type: none"> 1. Use Highland, rather than Pine as the as the boundary between Wards 1 &5 (would transfer 567 voters from 1 to 5) Result would be Ward 1=22229 (-1.3%) and Ward 5= 22199 (-1.2%). 2. Move area east of 24th between State and Center (near State Hospital) to Ward 6. (Boundary @ State). Ward 2=21,841 (.01%) Ward 6= 22370 (-1.9%) 3. Use Liberty as boundary between Wards 4 & 7. Would transfer 785 voters from Ward 4 to Ward 7 resulting in: Ward 4 = 21317 (.03%) and Ward 7= 21816 (.01%) <p>These changes would result in around a 600+ deficit in Wards 4 and 8 but that would be the most desirable to maintain some balance since those appear to be where the growth will be occurring in the next decade.</p>

I don't know the reason that my area and a big chunk of residential area on the north side of Silverton Road including Chemeketa College is outside the city boundaries. I note that an area south of my home, near Cordon Rd is also outside city boundaries.

For practical reasons, I think the boundaries should be changed to include these 2 residential areas. The side streets need sidewalks to make them safe for pedestrian, especially children walking to school.
