A RESOLUTION MODIFYING THE CITY OF SALEM PARKS, TRANSPORTATION, WATER, AND STORMWATER SYSTEM DEVELOPMENT CHARGE ELIGIBLE PROJECT LISTS

Whereas, SRC 41.100-SRC 41.190 authorizes the imposition of parks, transportation, water, and stormwater system development charges (SDCs) to fund capital improvements for the City of Salem parks, transportation, water, and stormwater systems; and

Whereas, City of Salem Resolution No. 2019-7 established SDCs for the City of Salem, adopted eligible project lists (309 Lists) as required by ORS 223.309, and adopted a methodology setting forth the basis for, and amount of, SDCs; and

Whereas, City of Salem Resolution No. 2019-25 modified 309 Lists for Water and Wastewater; and

Whereas, City of Salem Resolution No. 2020-6 modified 309 Lists for Transportation and Wastewater; and

Whereas, City of Salem Resolution No. 2021-1 modified 309 Lists for Parks, Transportation, and Wastewater; and

Whereas, City of Salem Resolution No. 2021-32 modified 309 Lists for Parks, Water, and Wastewater; and

Whereas, pursuant to ORS 223.309, the City of Salem may modify the 309 Lists at any time; and

Whereas, the City of Salem desires to modify the 309 Lists based on current development patterns; and

Whereas, the City Council hereby finds the modification to the 309 Lists to be necessary, proper, and authorized by law;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SALEM, OREGON, RESOLVES AS FOLLOWS:

Section 1. 309 Lists Modified. The Parks 309 List is modified as follows: add Community Park titled, "Woodmansee;" modify Community Park titled, "Fairview." The Transportation 309 list for Intersections is modified as follows: add project titled "State Street @ Greencrest Street;" remove projects titled, "12th Street SE @ Fairview Avenue SE," "Brown Road NE @ Sunnyview Road NE," and "McGilchrist Street SE @ 12th Street SE. The Transportation 309 list for Corridor Projects is modified as follows: add projects titled "Aumsville Highway SE from Deer Park Road to Urban Growth Boundary" and 'Hilfiker Lane Extension between 12th Street SE and Pringle Road SE;" remove project titled, "Fisher Road Extension from Sunnyview Road NE to Market Street NE." The Water 309 List is modified as follows: modify Pipes quantity under "S-2 – Feeder." The Stormwater 309 List under Attachment 2 of Resolution 2002-142 is modified as follows: add Battle Creek Basin project titled, "Upstream of BCB20." The 309 List Modifications are depicted on "Exhibit 1" and are incorporated herein by this reference.

Section 2. Modification of Prior Resolutions. This resolution modifies Resolution No. 2002-142, Resolution No. 2019-7, Resolution No. 2019-25, Resolution No. 2020-6, and Resolution 2021-1 and except as herein modified, Resolution No. 2019-7, Resolution No. 2019-25, Resolution No. 2020-6, and Resolution No. 2021-1, and Resolution No. 2021-32 remain in full force and effect.
