To whom it may concern,

I am a tenant of the Forum Apartment Complex. I wish to remain anonymous as I'd prefer not to aggravate any parties.

Setting up a micro shelter in the prescribed location is admirable, necessary, and a great use of land within the city. I think it would be the perfect place for micro shelters.

My fears are the following: lack of services lack of plumbing exaggerated police presence lack of upward mobility and an increase in issues in the area due to the above.

If such a shelter is to be put in place, we MUST provide the services necessary to create the possibility of upward mobility. We need job recruiting staff, mental health professionals, and general health professionals to provide the basic building blocks to enfranchise the unsheltered. The shelters must be safe & warm. Access to services must be immediate, consistent, and affable.

There are no bathrooms on site. They will need bathrooms, showers, etc. All of these improvements must function & provide safety for those seeking shelter. (ie: they must have doors that lock, etc)

I highly recommend creating a service similar to the San Francisco Streat Crisis Response Team as a stop gap measure to prevent the unnecessary use of LEOs. LEOs have an extraordinarily dangerous job. They are trained quite well for that. However, interactions with the unsheltered require a different approach. Furthermore, I'd rather have LEOs focused on violent crime rather than mental health crises. LEOs focus on violent crime is a much better use of taxpayer \$\$. Finally, by streamlining an approach to law enforcement, we may work towards reclaiming the respect the officers deserve due to their dedication to the community & an extraordinarily dangerous line of work.

I am sure there are a variety of other needs which I am not addressing. However, if these are met, I think the city will be able to mitigate any prospective increase in crime etc. We may create a safe community to reinfranchise the lost souls, and increase the stability & strength of Salem, Oregon, and, in some small way, set a positive example for the US as a whole.
