Hello,

I was reading the proposed Climate Action Plan and many of the items proposed seem to be programs that are already in place or have been and not utilized to the fullest. However, I noticed something in Appendix 8 that is confusing, and I would like clarification.

First: Does the action plan affect just within the Salem city limits or within the Urban Growth Boundary of the city of Salem.

Second: EN 20 states: Implement a City ordinance that requires a Home Energy Score be provided to prospective home buyers. Follow guidance from Home Energy Score programs established in other Oregon cities, including Portland and Milwaukie.

Who does that scoring and what all does it entail? What is the significance of having a score of 50 verses 90?

Third: EN 21 reads - Adopt **mandatory** home- and building-energy rating system requirements so that upon property sale, buildings (commercial and residential) are required to meet the energy rating system criteria. Work with non-profits and utilities to provide financial incentives when upgrading to new standards.

I read this to mean that the seller or the buyer will be mandated to upgrade the home to meet what the Energy Score programs require. Is this the intent? If so, I see many hardships for people both selling and buying, especially people with limited incomes in homes that have few updates.

IF the seller can afford to update, those costs will be added to the selling price to recoup that expense, making it even harder for the buyer to finance or pay the mortgage.

IF the seller cannot afford the updates are they not able to sell their home? I'm thinking of the 80 year old couple living on limited income in the home they bought in 1960 and now need to sell and move to care facilities. Or the young family wanting to sell their first home to get a bigger one but can't afford to pay for updates, are they also not able to sell their home?

There are so many scenarios of how this mandate would negatively impact the people trying to sell their home. It seems the emphasis on updating/upgrading homes to be more efficient would be better served by buyer programs where they can finance upgrades over the life of a mortgage.

The final draft of the [climate action] plan was released in November after 15 months of work by a 33-member community task force and multiple rounds of community engagement.

Patricia Farrell, the parks and natural resources planning manager for the Public Works Department, said the plan provides a roadmap for reducing greenhouse gas emissions and creating a resilient city while also considering equity in all strategies — meaning they don't want any of the suggestions to have a disproportionate impact on marginalized or lower-income residents.

Yet there is apparently no public hearing scheduled on the plan.

In October 2020 the Council adopted a goal to reduce greenhouse gas emissions by 50 percent by 2035. Since that adoption more than a year has passed. There are only 13 years left to achieve that goal. Several years will be needed to decide on how to implement the adopted plan and several more to begin implementation.

There has been no stated reason for delaying the scheduling of a public hearing on the final draft plan. Salem in the last two year has seen catastrophic wildfires and hazardous smoke pollution, an historic ice storm and unprecedented heat dome extreme temperatures in June. Delay in slowing climate change is unacceptable.

Message	It has come to my attention that Mayor Chuck Bennett is planning to withhold the draft Climate Action Plan from consideration by the City Council, and instead has asked the City Manager to recommend isolated "non-objectionable strategies" from the plan for approval in February. We do not know why Mayor Bennett has chosen to do this, or who "objected" to it and why, but this action is not acceptable. The Salem Climate Action Plan has been in the works for five years. In late 2020, Council approved the formation of a Climate Action Task Force, consisting of selected City Councilors and stakeholders from interests throughout the city, and they approved spending approximately \$170,000 of the taxpayers' money to hire a professional consulting firm, Verdis, to guide the Task Force through the process of negotiating and drawing up a comprehensive plan, on the understanding that Council would meet to review it at the beginning of 2022. 350 Salem OR Calls on Mayor Bennett to Stop Blocking Approval of the Climate Action Plan

Salem, Oregon – 350 Salem OR calls on Mayor Chuck Bennett to allow the City Council to consider the draft Salem Climate Action Plan. 350 Salem OR has learned that instead of allowing the City Council to approve or reject the draft Salem Climate Action Plan, the Mayor has directed the City Manager to recommend non-objectionable strategies from the plan to the Council for consideration in February.

Without Council approval, the draft plan won't have official status in future City discussions. Also, Council needs to reevaluate the plan every few years to assess progress on the Council's emission reduction goals. The draft plan is far more than just a list of short-term suggestions.

A report to City Council at their meeting on December 6th stated that "the final draft CAP will come to Council for consideration after the beginning of 2022", but no action has been scheduled.

The final draft of the Salem Climate Action Plan, released in November, was the result of a year of work by a 42-person Task Force appointed by the Mayor. The Task Force was led by the Verdis Group consultants who were paid approximately \$170,000 for their work on the plan.

350 Salem believes that the holdup is due to objections from Northwest Natural against elements of the plan that would reduce or eliminate the use of natural gas (fossil methane) in new developments. Houses built now will stand for 100 years and lock in decades of methane and carbon dioxide pollution. The greenhouse gas inventory completed in 2019 as part of the Climate Action Plan process showed that "stationary emissions," (mostly from natural gas) comprised 16% of total emissions in Salem.

"We object to Mayor Bennett holding up final approval of the Salem Climate Action Plan because of objections from the fossil fuel industry," said 350 Salem OR Co-Coordinator Phil Carver. "Northwest Natural has no right to veto Salem's plan so that they can forever contribute to the climate-related harms that we are already experiencing in Salem."

350 Salem OR began advocating for Salem to have a Climate Action Plan five years ago. Salem is the only major city in Oregon that does not already have an adopted Climate Action Plan.

Prof. Janet Lorenzen, an environmental sociologist at Willamette University explains, "I spent months volunteering my time on the Salem Climate Action Plan Task Force, we worked hard to prioritize both climate and equity, and now the Mayor seems to be caving to special interests who have a business model of unlimited growth and pollution. Residents on the side of clean air, climate resiliency, and racial justice don't even get a hearing."

"The Mayor's approach will never get us to the Council's adopted goal of cutting our emissions in half by 2035, just 13 short years away," said Phil Carver. "He should consider his legacy in his last year in office. We ask: Will he stand on the side of the fossil fuel industry or on the side of our children and grandchildren?"

350 Salem OR is the local affiliate of international climate action organization 350.org. The mission of 350 Salem OR is to build an inclusive grassroots movement that targets keeping fossil fuels in the ground, advocates for a just transition to a renewable energy economy, and supports community-based resilience in response to the climate crisis. "350" refers to the safe level of carbon dioxide (ppm) in the air, a level that the world passed in 1988. Today the level is 417 ppm, the highest level in the last 3 million years.
