3	Section 3. Extensions of Approval for Land Use Applications Submitted and/or			
4	Approved Prior to Ordinance Effective Date. Land use applications submitted and/or			
5	approved prior to the effective date of this ordinance that would require a Class 2			
6	extension approval as a result of changes to standards or criteria included in this			
6	ordinance or Engrossed Ordinance 13-21 may, notwithstanding the applicability and			
7	<u>approval criteria for Class 2 extensions included under SRC 300.850(b)(2)(B) and SRC</u> 300.850(b)(4)(B), receive Class 1 extension approval provided the decision has not			
8				
0	expired and there are remaining extensions available. Nothing in this section shall be			
9	<u>construed to grant more time or additional extensions beyond that which is otherwise</u>			
10	<u>allowed under the original approval.</u> <u>Section 34.</u> Codification. In preparing this ordinance for publication and distribution,			
11	the City Recorder shall not alter the sense, meaning, effect or substance of this ordinance,			
	but within such limitations, may:			
12	(a) Renumber sections and parts of sections of the ordinance;			
13	(a) Renamber sections and parts of sections of the ordinance,(b) Rearrange sections;			
14	(b) Rearrange sections,(c) Change reference numbers to agree with renumbered chapters, sections or other			
	parts;			
15	(d) Delete references to repealed sections;			
16	(e) Substitute the proper subsection, section or chapter, or other division numbers;			
17	(f) Change capitalization and spelling for the purpose of uniformity;			
17	(g) Add headings for purposes of grouping like sections together for ease of			
18	reference; and			
19	(h) Correct manifest clerical, grammatical or typographical errors.			
20	Section 45. Severability. Each section of this ordinance, and any part thereof, is			
20	severable, and if any part of this ordinance is held invalid by a court of competent			
21	jurisdiction, the remainder of this ordinance shall remain in full force and effect.
