I am writing to give written testimony for the Proposed Water/Sewer Rate Increase that will be on the agenda before you on July 25, 2022. I have attached a copy of my most current utility bills for your review. These bills show my current utilities for our house with a family of 4 as follows:

Water/Sewer = \$115.83 Natural Gas = \$92.00 Electric = \$86.00

This makes my current Water/Sewer bill 23% higher than my gas bill and 29.5% higher than my electric bill.

The proposed increase of 5% will make my water/sewer bill 28% higher than gas and almost 35% higher than electric.

This is simply unconscionable, especially in light of the fact that the citizens of Salem are faced with extremely high inflation and coping with high gas and grocery prices at the present time.

Our family has made changes this last year to reduce water, electric & gas consumption... to what end?

The cost from the City of Salem continues to rise even though our consumption has declined.

I beg you, on behalf of all families struggling under the weight of the current inflation, to represent your constituents and decline the proposed water/sewer increase. While 5% does not seem like much, it is excessive when our water/sewer utility would be, on average, over 30% more than our gas & electric utility billings.
