7	Section 1. The following Salem Revised Code (SRC) chapters are hereby amended as
8	set forth in Exhibit B, attached hereto and by reference incorporated herein: SRC 110,
	SRC 621, SRC 622, SRC 623, SRC 624, SRC 625, and SRC 900.
9	Section 2. The overlay zones identified in Exhibit A are eliminated from the Salem
10	Zoning Map as shown in that exhibit.
10	Section 3. Findings. This is a legislative land use amendment. Findings demonstrating
11	compliance with the applicable criteria are set forth in Exhibit C, which are attached
12	hereto and incorporated herein by reference.
13	Section 4. Codification. In preparing this ordinance for publication and distribution, the
	City Recorder shall not alter the sense, meaning, effect or substance of this ordinance, but
14	within such limitations, may:
15	(a) Renumber sections and parts of sections of the ordinance;
	(b) Rearrange sections;
16	(c) Change reference numbers to agree with renumbered chapters, sections or other
17	parts;
18	(d) Delete references to repealed sections;
10	(e) Substitute the proper subsection, section or chapter, or other division numbers;
19	(f) Change capitalization and spelling for the purpose of uniformity;
20	(g) Add headings for purposes of grouping like sections together for ease of
01	reference; and
21	(h) Correct manifest clerical, grammatical or typographical errors.

1	Section 5. Severability. Each section of this ordinance, and any part thereof, is
2	severable, and if any part of this ordinance is held invalid by a court of competent

4	public peace, health and safety, an emergency is declared to exist, and this ordinance shall be in
