Salem is a diverse community with well-established neighborhoods, a family-friendly ambiance, and a small- town feel. These qualities reflect values that contribute to a diverse, welcoming, inclusive, and friendly community.

This survey is conducted by Western Oregon University graduate students in partnership with the City of Salem Human Rights Commission (HRC).

Survey results are used to identify and implement ways to increase diversity, welcomeness, and inclusion in Salem. In 2022, the City of Salem added housing status as a protected class because survey results reflected that people experiencing homelessness were also experiencing significant discrimination. The survey isn't just a rote process; it is a path for systems change!
