# Revenue Task Force Charter Requirements



#### General Considerations

- 20-30 members and at least 2 alternates appointed by the City Council.
- Council seeks people who are:
  - Interested in learning, listening and asking good questions, and who can help connect with the broader community.
  - Demonstrate intellectual curiosity, a willingness to consider additional revenues, and a collaborative mindset.
  - Comfortable working in a group, interacting with people with a wide range of experiences, and treating each other and community members with respect.
  - Care deeply about the future of our community and value the services provided by the City to apply.


#### Task Force Representation


The Task Force should be broadly representative of the diversity that makes up our community including residents and business owners from all City wards, with a variety of lived experience, at varied life stages, and of varied ethnicity and backgrounds.


- Community members at large: Salem residents or business owners
- Two representatives from each ward, nominated by City Council members, and two at-large representatives nominated by the Mayor. Ward/atlarge representation may overlap with other affiliations.
- Chamber of Commerce representative
- Business representative
- Salem 350 representative
- Latino Business Alliance representative
- City employee union representative




- Thank you to the 157 applicants who expressed interest in joining the Revenue Task Force!

- In addition to these applicants, there will be one ex-officio member from the Oregon Department of Administrative Services






#### Task Force Representation

If the Council approves the current slate, the Task Force would have:

- 25 members, with representation from each ward and outside Salem
- Representation from 20 residents, 4 business or property owners, 1 worker/volunteer, and 0 students
- Some age diversity with higher representation from older applicants, with 1 member under 25, 2 (26-34), 4 (35-44), 5 (45-54), 6 (55-64), and 7 (65+)
- Some racial/ethnic/language diversity with 8 non-white applicants and 5 applicants who speak a language other than English at home
- Limited diversity in housing/security, with almost all applicants living in single-family homes (1 rents), 4 applicants reporting that they have earned less than a livable wage in the last five years, and 1 who has experienced shelter/food insecurity
