## Jurisdictional Survey Response Trends

#### **OPIOIDS**

80% rated opioids"a very great concern."

### NICOTINE

More concern about access to and use of nicotine products compared to cannabis products.

### CANNABIS

More knowledge about the risks and harms of vaping/smoking cannabis or cigarettes compared to youth use of opioids.



## Youth Tobacco Use

### VAPING


Inhalant delivery systems (IDS), commonly known as vapes, contain increasingly higher concentrations of nicotine. This has made them even more addictive than cigarettes.

### FLAVORS

- □ Flavored products have been the primary marketing tool used by Big Tobacco to hook youth.
  - 64% of 8th graders and 63.4% of 11th graders who used tobacco in the past 30 days reported using flavored products.


### ACCESS

 More than a quarter of students who vape (26.8%) report they got their tobacco or vaping products from sources under 21.




## Big Tobacco in the Retail Environment

- In 2022, marketing in the retail environment made up 97% of the tobacco industry's total marketing expenditures.
- Most of this budget was spent on price discounts and promotional allowances to make tobacco products cheap and visible.
- There are currently 276 licensed tobacco retailers in Marion County.
  - In 2023, 43 retailers (15.6%) sold tobacco products to persons under the age of 21.

- □ We work with schools and community groups to provide evidence-based curricula and other educational resources.


### POLICIES

## ALCOHOL AND DRUGS

## Youth and Substances



### MARIJUANA(CANNABIS)

- 31% of 11<sup>th</sup> graders in Marion County have tried marijuana at least once.
- 13% of 11<sup>th</sup> graders report using marijuana in the past 30 days.



### MEDICATIONS

- 6<sup>th</sup> graders report using RX medications that aren't theirs or differently than prescribed at *the same rate* as 8<sup>th</sup> and 11<sup>th</sup> graders.
- Fentanyl overdose deaths are the fastest growing among youth.



### ALCOHOL

- More than 1 in 10 11<sup>th</sup> graders have had alcohol in the past 30 days.
- Students report alcohol as being "easy to get".
- A majority of teens report getting alcohol from their parents.

During random checks, nearly 1 in 5 retailers sold alcohol to a minor. (OLCC, 2022-23)



## Youth Listening Sessions

*"Vaping is very common. Teens vape in the bathroom at school."* 

*"If [teens] are using nicotine in vapes, they will use weed."* 

"Alcohol is easy to come by. Family members usually give it to them"

High school students expressed concern for middle school students' vaping.

## FENTANYL



## FENTANYL



100X more potent than morphine, 50X stronger than heroin Synthetic fentanyl is being made into pills that look like other opioids (Oxycontin, etc.)

Youth and young adults are getting fake pills from social media, friends and others.

It only takes a tiny amount to cause a lethal overdose.

Fentanyl-related deaths are the fasted growing amongst youth.




## Lethal Dose of Fentanyl

### **Current Fentanyl Prevention Strategies**

Increase availability of naloxone (Narcan)

Community awareness and education

Senate Bill 238 requiring schools to teach students about the dangers of opioids
