5	The City of Salem ordains as follows:			
6	Section 1. Findings. Pursuant to ORS 197.010(1), an amendment to the Salem Area			
7	Comprehensive Plan Map must be approved by the City Council by ordinance. The Generalized			
8	Land Use Map contained in the Northeast Neighbors-Southeast Salem Neighborhood			
9	Association (NEN-SESNA) Neighborhood Plan was adopted as a component of the Salem Area			
10	Comprehensive Plan pursuant to SRC 64.015(9). The amendment to the Salem Area			
11	Comprehensive Plan Map is consistent with the criteria found in Salem Revised Code (SRC)			
12	64.025(e)(2) as set forth in "Exhibit 1," which is attached hereto and incorporated herein by			
13	reference.			
14	Section 2. The Salem Area Comprehensive Plan Map Designation, for an approximately 0.56-			
15	acre property at 2440 McGilchrist Street SE, as identified in "Exhibit 2," is changed from			
16	"Industrial" to "Industrial Commercial."			
17	Section 2. Codification. In preparing this ordinance for publication and distribution, the City			
18	Recorder shall not alter the sense, meaning, effect or substance of this ordinance, but within sucl			
19	limitations, may:			
20	(a) Renumber sections and parts of sections of the ordinance;			
21	(b) Rearrange sections;			
22	(c) Change reference numbers to agree with renumbered chapters, sections or other parts			
23	(d) Delete references to repealed sections;			
24	(e) Substitute the proper subsection, section or chapter, or other division numbers;			
25	(f) Change capitalization and spelling for the purpose of uniformity;			
26	(g) Add headings for purposes of grouping like sections together for ease of reference;			
27	and			
28	(h) Correct manifest clerical, grammatical or typographical errors.
