END NOTES TO CHANGE ORDERS:

- 1. Change Order No. 1 adds \$89,175.66:** Provides for reconstruction of haul routes crossing existing airfield pavements, specific geotechnical investigation, and an increase in the quantity of bituminous surface course used for paving operations.
- 2. Change Order No. 6 adds \$211,671.00:** Provides for additional time and effort as a result of construction delays. The construction delays resulted in additional time spent on construction engineering, construction support, construction inspection, and construction survey.
- 3. Change Order No. 2 adds \$75,000.00:** Provides for tire purchases for new fire trucks and additional purchases for the remainder fo the fiscal year.
- 4. Change Order No. 3 adds \$50,500.00:** Provides for additional work performed for right of way process related to necessary business relocations in accordance with all ODOT and federal requirements.
- 5. Change Order No. 2 adds \$40,000.00:** Ensures adequate funding for hardware procurements for the remainder of the fiscal year.
- 6. Change Order No. 1 adds \$193,000.00:** Provides for the completion of the procurements of Cisco hardware, software, and maintenance renewals for the remainder of the fiscal year.
- 7. Change Order No. 2 adds \$100,000.00:** Provides for the procurement of Microsoft Enterprise Exchange, McAfee annual maintenance renewal and additional add-on Microsoft application user licenses.
- 8. Change Order No. 4 adds \$25,000.00:** Provides for additional repairs throughout City owned buildings.
- 9. Change Order No. 1 adds \$50,000.00:** Provides for unanticipated repairs of a 36" transmission main.
- 10. Change Order No. 1 adds \$30,000.00:** Provides for the installation of wireless level monitors and rain gauges in identified manholes, the equipment will send alerts before surcharging the sanitary sewer lines.
- 11. Change Order No. 1 adds \$50,000.00:** Provides for an increased amount of sawcutting projects this fiscal year.
- 12. Change Order No. 3 adds \$50,000.00:** Provides for an unplanned large water pipe replacement.
- 13. Change Order No. 2 adds \$85,000.00:** Provides for unplanned repairs to a concrete street requiring immediate action and additional unplanned large repair projects.

These are non-exclusive, one-year contracts that may be renewed for up to four additional one-year renewal periods.
