3	The City of Salem ordains as follows:
4	Section 1. SRC Chapter 48 – Single Use Plastic Bags – is hereby created as set forth in Exhibit
5	A, attached hereto and by this reference incorporated herein.
5	Section 2. The Director responsible for enforcement of these provisions may exempt a retail
6	establishment from the implementation deadline for a period of not more than six months upon
7	the retail establishment showing, in writing, that timely imposition of the provisions of this
0	chapter would create an undue hardship not generally applicable to other persons in similar
8	circumstances. The Director shall make a written final decision to grant or deny the exemption
9	request, which shall be the City's final decision on the application.
10	Section 3. Effective Date of Regulations. The provisions of this chapter shall be
	effective:
11	(a) April 1, 2019, for retail establishments or food providers of stores within the city
12	that are greater than 10,000 square feet in size, and
13	(b) September 1, 2019, for all other retail establishments or food providers.
15	Section 4. Codification. In preparing this ordinance for publication and distribution, the
14	City Recorder shall not alter the sense, meaning, effect or substance of this ordinance, but
15	within such limitations, may:
1.6	(a) Renumber sections and parts of sections of the ordinance;
16	(b) Rearrange sections;
17	(c) Change reference numbers to agree with renumbered chapters, sections or other
18	parts;
10	(d) Delete references to repealed sections;
19	(e) Substitute the proper subsection, section or chapter, or other division numbers;
20	(f) Change capitalization and spelling for the purpose of uniformity;
21	(g) Add headings for purposes of grouping like sections together for ease of
21	reference; and
22	(h) Correct manifest clerical, grammatical or typographical errors.
