- **1.** Change Order No. 1 adds \$59,766: Provides for the preparation of technical specifications, evaluation criteria, and prepare electrical, insrumentation, and controls designed for new speed-controlled distributors.
- **2.** Change Order No. 1 adds \$32,732.60: Provides for additional requested services related to project re-initiation, public outreach, and stormwater modeling for the park master plan.
- **3.** Change Order No. 2 adds \$78,217.76: Provides for construction engineering support services, general construction support, construction quality control monitoring and inspection, and traffic engineering construction services.
