END NOTES TO CHANGE ORDERS:

- 1. Change Order No. 1 adds \$41,325.35:** Provides for a pressure reducing valve and concrete vault at the Aldersgate Dechlorination Trailer site.
- 2. Change Order No. 1 adds \$427,416:** Provides for permitting assistance, stormwater management design, and establishment of construction support services.
- 3. Change Order No. 1 and No. 2 adds \$32,430.30:** Provides for quantity over-runs, additional cost incurred to remove and reinstall curb, and install a catch basin with associated piping.

- 4. Change Order No. 1 adds \$32,000:** Underestimated usage for the fiscal year 2018-19.
- 5. Change Order No. 1 adds \$100,000:** Underestimated usage for the fiscal year 2018-19.
- 6. Change Order No. 6 and No. 7 adds \$71,266.66:** Provides for various quantity over-runs and additional bid items.
- 7. Change Order No. 1 adds \$80,000:** Underestimated usage for the fiscal year 2018-19.
- 8. Change Order No. 1 adds \$40,000:** Provides for an increase in funds for the Microsoft Enterprise License Agreement.
- 9. Change Order No. 1 adds \$136,000:** Provides for an increase in wireless service.
- 10. Change Order No. 1 adds \$65,000:** Provides for an increase in the amount of new residential and commercial services installed in fiscal year 2018-19. In addition, there are no longer existing replacement parts available for 1-1/2" and 2" meters resulting in a complete change of meter rather than the ability to repair existing meters.
- 11. Change Order No. 1 adds \$310,000:** Provides for a new security Enterprise License Agreement to improve network security through bundled software services and the replacement of aging infrastructure hardware.
- 12. Change Order No. 1 adds \$100,000:** Underestimated usage for fiscal year 2018-19.
