From June 2009 – Jan 2013, I worked as a community planner with the National Park Service, Chesapeake Bay Office. In this role, I ensured that projects funded by the NPS Chesapeake Bay Office complied with federal, state, and local law or policy. The detail and accuracy of my interpretation and conclusions on environmental and land-use planning issues was essential as the office funded a variety of projects in different states in the Chesapeake Bay watershed. I regularly provided clear, easily understandable technical assistance to partners for site-specific projects regarding partner responsibilities for compliance with federal, state, and local mandates, including jurisdictional land use restrictions, NEPA, NHPA, agency policy, and CEQ regulations. This included my work on the Comprehensive Management Plans / Environmental Assessments (CMP/EAs) for the Captain John Smith National Historic Trail and the Star-Spangled Banner National Historic Trail. Prior to working with the NPS, I volunteered with the historic preservation advocacy organization, Preservation Action. This organization is focused on federal level advocacy and outreach, and as a volunteer Policy Writer from Aug 2008 – Jun 2009, I was the sole author of "Grassroots Guide to Historic Preservation & the 2008 Farm Bill," a plain language description of technical preservation and resource protection policies, produced and distributed by Preservation Action. My responsibilities included all research, writing, and preliminary design and layout.
