A RESOLUTION DECLARING THE PUBLIC NEED TO ACQUIRE REAL PROPERTY FOR THE PURPOSE OF EXTENDING FISHER ROAD NE TO MARKET STREET NE

Whereas, for the purposes of the Fisher Road NE Extension Improvement Project ("Project"), it is necessary for the City of Salem ("City") to acquire right-of-way, and temporary construction and permanent easements, over certain real property depicted on "Exhibit 1," which is attached hereto and incorporated herein by reference ("the Properties"); and

Whereas, the extension of Fisher Road NE to Market Street NE is an approved capital improvement project currently being designed for construction; and

Whereas, for the public purposes of improving the streets within the City, including the construction of the Project, the City Council has deemed necessary the acquisition of certain Properties or property rights, which the City is authorized by law to acquire.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SALEM RESOLVES AS FOLLOWS:

Section 1. The City does hereby find the Project to be in the public interest and declares a public need for the Properties in order to construct the public improvements for the Project.


