35g CART: RATE COMPONENT SPECIFIED FOR RECYCLING REVENUE LOSS

Independence. Approved. Recycling component \$1.90

Keizer Pending. Expect recycling component to be about \$2.00

Monmouth Approved. Recycling component \$1.90

Silverton Pending. Will request recycling component of \$2.00

Wilsonville Approved. Recycling component \$2.50

NOTE: Many jurisdictions around the state did an “accelerated increase” early in the year because of the specific recognition that recycling revenue losses were impacting operating margins. However, they tended to roll all known costs at the time of the “accelerated increase” into the new rate. Some stated it as a “temporary” rate that could be further adjusted later in the year. In these instances, they did not specifically break out the portion related to recycling loss but included it in all the known factors for needing an increased rate.
