Currently I am serving as the Oregon Real Estate Agency's (OREA) Customer Service Manager. In this role I'm responsible for overseeing the licensing and education programs for real estate brokers, principal brokers, property managers, and escrow organizations. In addition, I am a licensed real estate broker (on a hold status due to my employment with the Oregon Real Estate Agency). The housing industry is truly a passion of mine and I believe my valuable skills could serve the City of Salem well. Since 2015 I've acted as the Agency's expert related to the licensing and education programs which requires writing laws and rules. In addition, I'm responsible for tracking and monitoring legislative bills that could impact the real estate industries, landlord tenant laws, housing policies, and stakeholders. Throughout my years with the Agency I've lead communication efforts pertaining to the programs I oversee. I've developed and provided educational courses and public presentations to licensees, education providers, and industry stakeholders. In September of 2016 the OREA began to phase education providers into the online system (as all licensees had previously converted). I organized an Educator's summit where I demonstrated the new online experiences to all of the licensed real estate career schools within the state of Oregon. At this event educators offered suggestions for processes improvements and I was able to accommodate those changes into the online applications. In 2017 I was instrumental with the formation of a workgroup created to review the Oregon Real Estate Agency's 2018-2019 mandatory Law and Rule Required Course. As the primary facilitator I was responsible for engaging industry leaders, including key stakeholders, educators, Board members, and representatives of the Oregon Association of Realtors, and the Building Owners and Managers Association of Oregon to review the proposed content outline and provide them with an opportunity to make recommendations. There were moments of conflict where workgroup members disagreed with the role of the Agency. I listened to the issues and concerns members raised and then recommended solutions that satisfied their needs, yet still within the scope of the Agency's authority. One of my favorite roles within my position is acting as an advocate for licensees who've experienced a hardship and are requesting the waiver of a requirement. When a licensee contacts me I gather the details and clearly identify the circumstances which were beyond the licensee's control. I then inform the Commissioner of the request and provide guidance on deciding if the request warrants an approval or denial. I repeatedly refer to historical requests to ensure continuity on behalf of the Commissioner. Currently I'm an active member with the Association of Real Estate License Law Officials (ARELLO), and serving as the Co-Vice Chair on the Exam Accreditation Committee. In 2020 I will be installed as the Committee Chair. Throughout the years I've built valuable relationships with licensees, board members, industry leaders, and association leaders. Many in the community still contact me directly on a regular basis when they have questions or issues regarding OREA's laws and rules or if they experience complications with the online system. I've built a reputation to be a highly valued resource to the real estate community including real estate commissions throughout the United States, the Association of Realtors, and various other associations located throughout the state. These relationships have served the entire Agency well, as other business and legislative policy changes have pursued. My passion for the real estate and housing industry has continued to grow and in 2018 I obtained my real estate license (due to my position with OREA my license is on a "hold" status). I pride myself in my work and my ability to provide excellent customer service. I have an ability to handle responsibility and build positive relationships with work colleagues at all levels. I very much hope that you will look favorably upon my application by recognizing my enthusiasm, talents and my future potential.
