WHEREAS, on April 11, 2016, first reading of the proposed establishment of Salem Revised Code (SRC) Chapter 82, Clearing and Grading, was held by City Council and referred to the Planning Commission to receive testimony regarding the proposed chapter; and

WHEREAS, after due notice, a public hearing on proposed Chapter 82 was held before the Planning Commission on May 3, 2016, at which time witnesses were heard and testimony received; and

WHEREAS, the Planning Commission having carefully considered the entire record of this proceeding, including the testimony presented at the hearing, and after due deliberation and being fully advised;

NOW THEREFORE BE IT RESOLVED BY THE PLANNING COMMISSION OF THE CITY OF SALEM, OREGON:

Section 1. FINDINGS:

The Planning Commission hereby adopts as its findings of fact the staff report on this matter dated May 3, 2016, herewith attached and by this reference incorporated herein.

Certified Professional: Any person licensed in Oregon as a civil engineer, engineering geologist, architect, or landscape architect and who possesses the knowledge, experience, and ability to successfully design and oversee a project regulated by this Chapter.
