- Identification of the site for the police facility as identified by City Council,
- The use of the bond funds shall include site acquisition and development of a police facility and related costs.
- "Related costs" include site acquisition and preparation, and abutting street improvements.
- Any bond savings realized after completion of the Police Facility may be used for renovation and improvements to the space at the Civic Center to be vacated by the Police Department,
- An estimate of the effect of the measure on the property tax liability for a representative residential property owner, in terms of dollars per \$1,000 of assessed value, a per month and per year estimate for a \$200,000 home,
- That the facility will be approximately 148,000 square feet of building area, and include the Willamette Valley Communication Center.
