10	Section 2. 4318 Lone Oak Road SE. The Salem Area Comprehenisve Plan Map Designation,				
11	for 4318 Lone Oak Road SE, as idenitifed in "Exhibit 2," is changed from from "Single Family				
12	Residential" to "Parks, Open Space and Outdoor Recreation."				
13	Section 2. Codification. In preparing this ordinance for publication and distribution, the City				
14	Recorder shall not alter the sense, meaning, effect or substance of this ordinance, but within such				
15	limitations, may:				
16	(a) Renumber sections and parts of sections of the ordinance;				
17	(b) Rearrange sections;				
18	(c) Change reference numbers to agree with renumbered chapters, sections or other parts				
19	(d) Delete references to repealed sections;				
20	(e) Substitute the proper subsection, section or chapter, or other division numbers;				
21	(f) Change capitalization and spelling for the purpose of uniformity;				
22	(g) Add headings for purposes of grouping like sections together for ease of reference;				
23	and				
24	(h) Correct manifest clerical, grammatical or typographical errors.
