The CSHC also needs members who are familiar with parliamentary procedure, understand how to read a financial statement, analyze a budget, think critically and ask difficult questions. Finally, the CSHC also needs members who are practical, and yet have a vision for and want to encourage a truly collaborative approach to addressing Salem's affordable housing and social service needs. In addition to my excellent record for attendance and punctuality, I believe I have something to contribute in these areas.

Do you have experience in Project Management? If yes, please provide a brief summary of your experience.

Yes, assuming the term "project management" doesn't have some specialized meaning, but just means an "undertaking requiring concerted effort."
