- Message Body: April 20, 2017 Dear Mayor and City Council members, I am a part-time Uber driver that has moved to Salem, OR (to help out my 83 year old father) - and I need a part-time job to earn money. Today, I must drive 34 miles (each way) just to reach the county border in the Portland metro area - so that I can work and give potential riders an opportunity to use the driving services of our transportation company. In 10 months of 2016 - I drove 7,700 commute miles (no income earned) - just to get to the Wilsonville, OR area - so that I could work and earn money with Uber. All of these commute miles would not be necessary if I could work and drive for Uber in the Salem metro area. I know that many Salem area residents and visitors are frustrated with the fact that Uber or other transportation service companies are not allowed to operate in other areas of the state (outside the Portland metro area). Last night I gave a ride to a passenger from downtown Portland to Salem; however, this person expressed a lot of frustration knowing that he could not take an Uber ride back to Portland metro area the next day. I suggested he rent a car - which he said would be a major inconvenience for him. This rider also said a taxi cab ride would be much more expensive than Uber (and probably cost about twice the price). He could not understand how a city the size of Salem (and the capital of Oregon) could have decided they do not need Uber's transportation company to serve the needs of Salem residents and visitors to this area. Please reconsider your decision to ban Uber - and vote to allow Uber and other transportation network companies an opportunity to operate in the Salem area - as well as other cities in Oregon (Eugene, Corvallis, Bend, etc.). - Message Body: Mr. Powers, The Salem city council on the January 14th meeting a motion was made by council member Andersen that Willamette Valley Yellow Cab and other taxi companies be involved in the development of the new rules regarding taxis and rideshare companies. The motion was seconded and the city staff was so directed. I do not believe that by receiving a letter a day or two before the city council meeting with the new rules already (written by Uber) constitutes involvement; though I did send some opinions that were thwarted. In my opinion the directive by the city council needs to be carried out to before any changes are fully legal. Mayor Bennett needs to appoint a council committee including Willamette Valley Yellow Cab and other Taxi companies and representatives from the community to rewrite the rules. I'm very confused by this email. It sounds like this email is used to confirm that I was involved with the rewrite of the TNC and taxi ordinance to maintain parity. I was not involved as directed by City council or as personally promised by Mayor Bennett. All we asked for was fairness and a level competitive playing field.
