For plan review and re-checks associated with plan review, the Agency agrees to pay the City 65% of the total plan review fee for each new plan review. **For engineering consultation, the Agency agrees to pay the City at a rate of \$100.00 per hour.**
3. Except as expressly amended above, all other terms and conditions of original agreement are still in full force and effect. Contractor certifies that the representations, warranties and certifications contained in the original Agreement are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.
