Dear City Council Members,

I am writing to strongly oppose your proposed construction of Marine Drive in West Salem. Not only will it encroach on Pioneer Village, where I live, but it would destroy the quiet neighborhood that defines Pioneer Village. Those of us who live here are seniors and disabled people. Much of the reason, beyond the subsidized housing break, that many of us live here as opposed to other places in Salem that have subsidized housing, is that it is quiet and relatively safe from violence and crime.

Putting a road where you suggest will only destroy that sense of peace that those of us who live here in Pioneer Village depend upon. From a very personal standpoint, I have severe PTSD, and it is hard enough for me to go out to Taybin Rd parking without having a panic attack, even with a service dog. Having higher traffic volume would destroy what sense of safety I have. I will no longer feel as though I can at least attempt to walk in this neighborhood for exercise and to run errands to Roth's and other services available along Wallace Rd and Glen Creek Rd, such as the post office and banks. Additionally, the construction would be horrendous and mean that parking and access to my apartment, as well as to many others would be compromised for several months.

There is NOT enough traffic on Wallace Rd to justify the cost of building this road which will only destroy neighborhoods, but will not really solve the traffic problems. It MAY take 5 to 10 extra minutes during heavy traffic time twice a day on Wallace Rd? So what? I deal with it. Is is sometimes a little frustrating? Yes, but those few extra minutes are not going to destroy anyone's day. We do not live in a big city where one's commute takes hours. Let's not pretend we do and build an unnecessary road. Spending 3.6 million dollars here makes no sense! Several of the buildings along the back end of the complex and along Taybin Rd would be exposed to high traffic levels and encroached upon, and to what purpose? The money would be better spent to buy the right of way north of 5th Avenue instead.

Leave our neighborhood ALONE!

I urge you to vote to defeat this proposed road and look at other alternatives with which to spend the money more judisciously and without destroying what Pioneer Village is and does for its residents.
